- \* Direct loans are disbursed equally in 2 payments if planned enrollment is for fall and spring.
- \* If you are requesting a loan for one semester, your eligibility will be based on costs for one semester and your loan amount will be adjusted accordingly.
- \* The amount you request may not be the amount you are eligible to receive.
- \* Loans for undergraduates are subject to proration when the student's final period of enrollment is shorter than an academic year.

***Students considered independent by federal guidelines, or whose parents are unable to borrow a Direct PLUS Loan, may be eligible to borrow an additional Unsubsidized Stafford loan in the amount of \$4,000 (first and second years) and \$5,000 (third year and beyond). Graduate students are eligible to borrow up to \$20,500 in Direct Unsubsidized loan.***
