



Step    How to view your Paycheck Statement: Benefit Credits and Deductions																															
Navigation: Employee Self Service > Payroll > Paychecks																															
<b>1</b>	In this document, we will review how the benefit credits and deductions have changed for 2021, and how they are reflected on paycheck statement going forward.																														
<b>2</b>	<p>Open the Payroll tile from Employee Self Service</p> 																														
<b>3</b>	<p>Click on your most recent paycheck statement, starting with check date 01/15/2021. The default sorting will have the most recent paycheck statement at the top.</p> <p>Use the funnel icon in the upper left to view additional date ranges.</p> 																														
<b>4</b>	<p>The benefit sooner credits will no longer be reflected under the “Hours and Earnings” section of your paycheck statement. <b>5</b>	<p>The benefit deductions will still be located in the “Before-Tax Deductions” section, however, the amounts reflected will be the employee’s share only.
