Direct - Course Embedded Assessment

Assessment Method Description

1) Students are required to pass four sequential semesters of music theory courses. Direct measures are taken through homework assignments, midterms, and final examinations across the four-semester sequence.

At the end of four semesters of theory students should be able to:

- a) Aurally identify form and major sections of musical structure,
- b) Through score analysis be able to identify major key areas, cadences, phrases and thematic content,
- c) Define the field-specific terminology related to the structure of a musical work,

d) In longer written assignments and essay questions, apply their analytical skills and disciplinary vocabulary to the analysis of specific movements and works.

Performance Target

Instructors expect 85% of students to meet or exceed expectations on the final exam.

For Fall 2022, 359 students enrolled in major applied lessons and performed juries; for Spring 2023, 310 students enrolled in major applied lessons and performed juries. 355 students in the fall 2022 and 309 students in the spring 2023 met or exceeded expectations. (Success rate is 99%). Juries are required for all BA, BME, BMA, and BM degrees. We do not actively track student success rate in the sequence by degree program. However, the School of Music implemented an online jury-grade system for 2023-24 academic year and will be able to track student success rate by degree program for next year's Assessment Report. A total of 669 students performed juries.

The research project should reflect their study and experience in the undergraduate curriculum, including, but not limited to, music theory, musicology, conducting, composition, entrepreneurship, career development, and ensemble participation.
