What's Happening?

You may have noticed some new courses/course titles published in various content/systems. As CMHC faculty update the program to meet the newest professional standards, you will see new course names appear.

Is every course impacted?

No. To see a list of impacted courses, see the tables on page 2.

Why is this Happening?

The update of course titles is occurring for two reasons:

- First, updating titles and offerings allows the program to stay as current as possible with professional standards, ensuring you are as prepared as possible upon graduation.
- Secondly, in an effort to increase engagement and tailor material specific to LPC track students, CMHC specific classes will only be available to CMHC students. To systematically accomplish this, new titles needed to be introduced. (i.e. Theoretical Foundations in Human Relations will now be Counseling Theories in Clinical Mental Health Counseling).

Will my degree requirements change?

No. Your degree requirements will be the same, though some class titles may change. To see a reconciliation of class titles, see the tables below. If you take a class with an updated title, you will receive credit for the associated original title on your program of study. This is completed through a behind the scenes process within the Department of Human Relations. For example, if you take Counseling Theories in Clinical Mental Health Counseling, you will receive credit for Theoretical Foundations of Human Relations which is listed on your Program of Study.

Which title will show on my transcript?

Your transcript will show the title as it appeared when you enrolled.

Are the new courses board approved?

Yes, all past and current course titles and offerings are approved by the State of Oklahoma Board of Behavioral Health Licensing. <u>Click here</u> for more information. If you are seeking licensure outside of Oklahoma, be sure to check with your state on course requirements.

Does the covered material change when the title is updated?

Generally, no. You may see some titles expand slightly (e.g. Crisis Intervention changed by adding Trauma Counseling), but the differences in material covered is not significant.

Regularly, faculty review covered material for specific classes and update the material to reflect the most recent standards, trends, and research. That process will continue.
