## C S 2813-001: Discrete Structures

**COURSE DESCRIPTION AND PREREQUISITES:** Prerequisite: C S 2334; MATH 2423 or MATH 2924 as prerequisite or concurrent enrollment. Introduction to the theory of discrete structures useful in computer science. Topics include combinatorics, relations, functions, computational complexity, recurrences, and graph theory.

**REQUIRED AND RECOMMENDED TEXTS:** "Discrete Mathematics: An Open Introduction" by Oscar Levin which is available for free <u>here</u> Another excellent textbook which I would recommend is "Book of Proof" by Richard Hammack, also freely available <u>here</u>

**GOALS AND OBJECTIVES:** By the end of the course, students will be able to: communicate and defend mathematical ideas; define and give examples of introductory discrete and proof terminology; revise and critique mathematical arguments; classify and reproduce proof techniques; produce conjectures

**GRADING:** Grades are determined by participation (15%), two exams (30%), homework (15%), quizzes (20%), and a cumulative final exam (20%). The *minimum* grade you need in order to attain each letter grades is:

Any estimated final grade calculated by Canvas are not to be considered official grades. Except where otherwise noted, no late work will be accepted nor will any exams, homework, or quiz grades be dropped.

ATTENDANCE: It is important to attend class regularly and engage in the material.

**GROUPS:** Most days will consist almost exclusively of group work. Groups will be randomly assigned and students will be assigned seats in the classroom to facilitate the group work.

**HOMEWORK:** Homework will be assigned each week. Assignments will be posted on Canvas. Students are allowed to discuss problems (especially with your group) however all submitted work must be in your own words, as you understand it.

**QUIZZES:** Readings will be assigned for a class day over material to be discussed that day. In order to insure students are prepared for the days activities, most class days will include a short quiz at the start of class. Students should be prepared to provide definitions, examples, counterexamples, or short proofs on these quizzes.

**PARTICIPATION:** Most class days will consist of students, working in groups, on a collection of problems, practicing the material at hand. Outside of class, students will be asked to present their group's solution to one of the problems discussed that day. Presentations will consist of a written solution alongside a video explanation of the thought process. One student from each group will be randomly selected to present a randomly selected problem each class day but all group members will receive the same grade.

**EXAMS:** There will be two exams during the semester, taken during regular class time, in addition to a cumulative final exam. The following is the approximate schedule of the exams. Should we need to deviate from this schedule to better serve the goals of the course, students will be notified in advance.

Exam 1: Wednesday, February 21

Exam 2: Friday, April 12

The cumulative final exam will be, as officially scheduled, May 8 from 1:30-3:30 PM.
