# **Description of General Business**

#### **Program Proposals and Modifications**

- The Community Counseling M.Ed. program name and requirement change was approved by unanimous vote.
- The Computer Science Accelerated B.S./M.S. program requirement change was approved by unanimous vote.
- The Computer Science M.S. program requirement change was approved by unanimous vote.
- The Computer Science Ph.D. program requirement change was approved by unanimous vote.
- The Engineering Physics M.S. program requirement change was approved by unanimous vote
- The Engineering Physics Ph.D. program requirement change was approved by unanimous vote.
- The Physics M.S. program requirement change was approved by unanimous vote.
- The Physics Ph.D. program requirement change was approved by unanimous vote.
- The Political Science M.A. program requirement change was approved by unanimous vote.
- The proposed Graduate Certificate in Research and Evaluation was tabled for clarification.
- The Social Work MSW program requirement change was approved by unanimous vote.
- The Social Work (Advanced Standing) MSW program requirement change was unanimous vote.

#### **Discussion Items**

• Self-Plagiarism and Exams – Is it plagiarism to use previous work

- Dean's Evaluation Irv Wagner gave a brief report on the dean's evaluation. The evaluation committee is waiting for results
- Graduate Management Systems Project Update Had the first focus group meeting with a dozen departments a week ago to find out what information departments are gathering, how they are gathering it, and why. Would like to develop or find a single-package graduate management system that can be used by the Graduate College and departments. Departments are making use of the annual evaluation form. A number of departments have added a "needs improvement" category to the annual evaluation form. How much are departments are using grade reports? A lot of departments would like more reports. We would like the graduate management system to hold all of that information so the Graduate College will be able to pull report information

# **Subcommittee Reports**

- Dr. Gutierrez provided the following APR reports:
  - The APR met on October 3, 2013 to provide an overview of the process and review the procedures for the reviews.
    - The programs to be reviewed are:
      - Political Science;
      - Film and Video Studies:
      - African and African-American Studies;
      - Modern Languages, Literature and Linguistics;
      - Religious Studies;
      - Psychology;
      - Sociology;
      - Honors College.
  - The APR met on October 17, 2013 with Dean Kelly Damphousse to get his insights into the College of Arts and Sciences departments being reviewed.
  - The committee was divided into two subcommittees. Each subcommittee will review half of the programs.
  - On November 13, 2013, the committee met to discuss the Department of Political Science.
- Dr. Ayres provided the following Faculty Senate reports:
  - o October 14 meeting:
    - President Boren spoke to the Faculty Senate. He indicated that, consistent with the recommendations of the Faculty Senate, if small raise funds are

- available (2% or less), raises should be across-the-board. If there are funds for larger raises there should be consideration of merit.
- Human Resource assistant director, Nick Kelly gave a presentation on benefits. The plans remain the same as last year, but costs are higher. The highest cost increase is in the HMO plan, where the employee increases range from 13%-30% depending on coverage selected.

## o November 13 meeting:

- Deans Rick Luce (University Libraries) and Lee Williams (Graduate College) spoke at the Faculty Senate meeting about the new open access policy and dissertation repository. Both OU and OSU dissertations are now deposited on ShareOK.org. The issue of embargos on dissertations was discussed. Dean Luce shared the embargo period used at a number of other institutions. Most were in the range of six months to two years. A number of questions were raised from faculty regarding changes in the library and policies regarding open access and Shareok. Faculty with concerns about the embargo policy was asked to submit concerns by 11/25.
- There were some changes in the faculty handbook approved related to accommodations for student athletes for exams, makeup exams and final exams. These mainly involved specifically listing intercollegiate athletics competitions in Provost-approved University sponsored activities.
- Paul Spicer presented a reapportionment of the Research Council membership. This will be voted on at the December meeting. The purpose is to add more members from the social sciences, humanities and the arts in order to facilitate more reviewers for Research Council funded proposals in these areas.
- Dr. Fiedler provided the following report on the November 21, 2013 HSC Graduate Council meeting:
  - o Dr. Tomasek announces he will step down as Dean of Graduate College. He will become VPR of Research.
  - Standardized form released for student evaluation of graduate courses. All graduate courses must be evaluated by students.
  - o Graduate Faculty appointments approved.
  - Report from HSC Faculty Senate: Implementation of ACA will require some changes to insurance plan for HSC employees, including student plans.
    Apparently HSC administration official(s) confess "ACA is not fully understood yet".

- Independent of ACA, there was a question about OU policy: if a 26-year-old stays on parent's plan, and decline OU plan, is the student reimbursed? Apparently HSC policy is now, and will continue to be, "no" ...
- Online form released for annual evaluation of all students by their advisory committee (before start of fall semester).
- New rule and form for change of supervisory committee: only two signatures now required. The chair and graduate liaison.
- "Responsible Conduct of Research" training required of all graduate students and post-docs, every four years. "Refresher" training apparently will be different from initial training.
- o 125 Anniversary of OU. There will be a development campaign (i.e. the Anniversary will be used to inspire people to donate \$).
