- ADPs and GPA Requirements
 - Accelerated degree program (ADP) students have been held to a high academic standard with regard to letter grades. For students admitted to an ADP, an undergraduate, graduate, or overall GPA below 3.0 would result in disenrollment from the ADP (with the option to

apply to the stand-alone master's, forgoing use of any credit applied toward the bachelor's degree). In keeping with the new Graduate College focus on term-based GPA, rather than cumulative GPA, the progress of ADP students will now be based on their term GPA, including undergraduate and/or graduate coursework.
