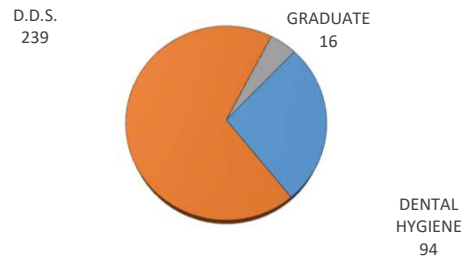

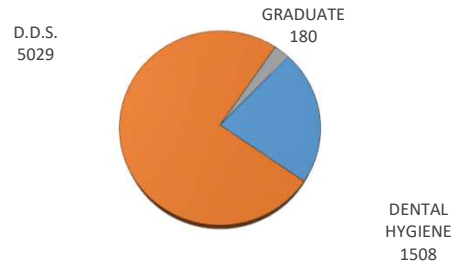

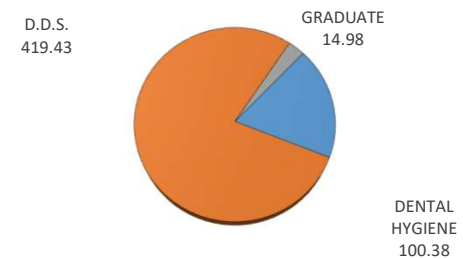
HEADCOUNT ENROLLMENT
