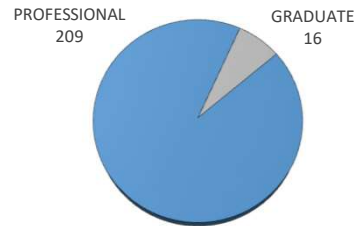

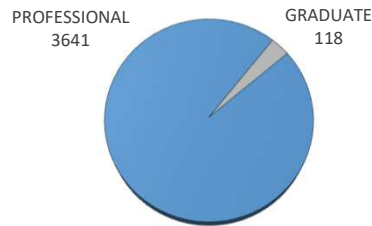

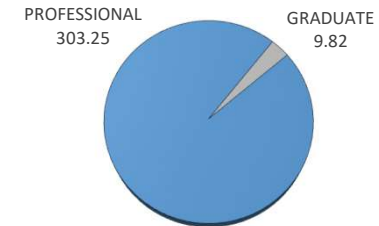
HEADCOUNT ENROLLMENT
