She is also Private Equity International's keynote to hundreds of Chief Compliance Officers and compliance professionals for the upcoming Private Fund Compliance Forum in New York. She is also a humanitarian and international television commentator who appears regularly as a CNN Español analyst to over 93 million viewers throughout the U.S. and Latin America. She is frequently described as "an audience grabber" and as having "the unique ability to speak to captains of industry, college students, and academicians all in the same audience."

Her research, scholarly work, and publications focus on laws at the international level, where multijurisdictional laws conflict and possible outcomes for corporate non-compliance includes high penalties, criminal liability, and physical danger for executives in foreign territories. She is a former member of the Advisory Committee of the World Economic Forum's Partnering Against Corruption Initiative; former delegate of the Asian-Pacific Economic Cooperation (APEC) CEO Summit in Chile; former Amnesty International USA board member; is a recipient of the 2019 Cybersecurity Woman Law and Privacy Professional of the Year Award that celebrates "female cybersecurity leaders changing the world;" and was featured in Women in Security Changing the Face of Technology and Innovation. The former Regional Counsel for a Fortune 10 company and former Assistant General Counsel for a publicly-traded financial institution has two decades of experience representing multinationals on issues related to global threats and governance in the U.S. and abroad. A visionary thinker with fluency in four languages and multiple law degrees from Georgetown and Notre Dame, she has extensive experience advising, training, and educating Executive Management. The co-author of two books on global threats that the Institute for Supply Management (ISM) adopted to commemorate their centennial anniversary, she has served as a keynote at more than 140 industry conferences through organizations such as ISSA, ISACA, SCCE, CSA, CIEPLAN, Institute of Internal Auditors (IIA), and Rotary International.

COREY PHELPS joined the University of Oklahoma in July 2020 as the Dean of the Michael F. Price College of Business. He previously served as Associate Dean of Executive Education for the Faculty, Associate Professor of Strategy, and Desautels Faculty Fellow at the Desautels Faculty of Management at McGill University. Professor Phelps oversaw three executive masters programs (the McGill-HEC EMBA, IMPM, and IMHL) and the McGill Executive Institute, which is responsible for public and customized executive programs. He was also a member of the Faculty executive and academic committees. Prior to arriving at McGill, he was a faculty member at HEC Paris (2009-2014) and the Foster School of Business, University of Washington (2001-2009). He completed his Ph.D. at the Stern School of Business, New York University.

At McGill, Professor Phelps taught in the MBA, EMBA, PhD, and executive education programs. At HEC, he taught in similar programs and directed the HEC-Atos GOLD Talent Development Program, which received the EFMD Excellence in Practice Award for best custom talent development program. His extensive executive teaching and program development experience includes programs in Europe, North America, Asia and the Middle East. Professor Phelps received the 2012 Pierre Vernimmen BNP Paribas Award for the best-teaching at HEC. At UW, he received undergraduate and MBA professor of the year awards and was a finalist for the University's Distinguished Teaching Award.


James L. Regens, Ph.D.

JAMES L. REGENS is Regents Professor and the founding Director, University of Oklahoma Center for Intelligence and National Security, *an Intelligence Community Center for Academic Excellence*. Dr. Regens is a member of the Council on Foreign Relations, International Institute for Strategic Studies, Association of Former Intelligence Officers, and International Association for Intelligence Education.

He is a Professor of Strategic Communication, Gaylord College of Journalism and Mass Communication and is an Adjunct Professor of Psychiatry and Behavioral Sciences at the OU Health Sciences Center. He was the founding Director of the OUSC Center for Biosecurity Research and Presidential Professor. He previously held the Edward E. and Helen T. Bartlett Foundation Chair at OUHSC and the Freeport-McMoRan Chair at Tulane.

Dr. Regens has authored and co-authored over 200 publications including articles in journals such as *Proceedings of the National Academy of Sciences*, *Intelligence and National Security*, *Journal of Cognitive Engineering & Decision Making*, *Leukemia*, *Dynamics of Asymmetric Conflict*, *Globalization and Health* and eight books. He has been PI for over \$40 million in research funding, primarily from the Office of the Director of National Intelligence, Department of Defense, Department of Energy, and Department of Homeland Security to conduct a series of large-scale, interdisciplinary projects. His research focuses on intelligence-based adversarial threat characterization; computational modeling; bioinformatics; advanced video analytics; dispersion, deposition, and persistence of bioaerosols, chemical agents, and fissile/non-fissile radioactive material; mechanisms to attenuate biological pathogen virulence; and biomarkers of non-traditional chemical agent exposure. He holds multiple U.S. patents.

He served in policy and analytical positions in the U.S. Government and national laboratories and in the USMC as well as a tenured faculty member at major research universities. Dr. Regens has demonstrated expertise in modeling/simulation, risk assessment, statistical and spatial analysis techniques, and decision analysis. He has field experience in Western Europe, Russia, China, the Middle East, Latin America, and sub-Saharan Africa. He has chaired multiple International Atomic Energy Agency technical committees and is a former chair of the Group on Energy and Environment, Organization for Economic Cooperation Development. Dr. Regens has been a consultant to and/or has served on review panels for numerous organizations including the U.S. Special Operations Command, Defense Threat Reduction Agency, Central Intelligence Agency, Defense Intelligence Agency, U.S. Department of Homeland Security, National Institutes of Health, National Academy of

Together with MIS faculty, she has implemented many curricular changes that have led to dramatic increases in enrollment in the undergraduate and graduate programs, and national ranking. Her research focus is to enhance human-technology interactions, particularly in work environments. From a micro-perspective, her research examines how user learning and training coupled with system design enhances individual employee competencies, contributes to decision making processes, and augments their interactions with technology. From a macro perspective, her research focus is to identify ways by which organizations can support employees in collectively appropriating the benefits of implementing new information technologies. Her recent research explores gamification systems as a way to learn and motivate employees to work with technology systems. She has received external funding to support her research on facilitating employee learning of new technologies. Her research findings have been published in a variety of leading journals. Her research complements her teaching interests in decision aiding systems, analytics, systems design, and management of technology. Her research findings on learning technologies, e-learning and collaborative learning directly impact teaching and are incorporated in her course design.






Honorable Eduardo Aninat

- Honorable Eduardo Aninat served as Finance Minister of Chile from 1994 to 1999. He has also held a variety of leadership roles with the International Monetary Fund (IMF) and the World Bank. Most notably, he served as the Chairman of the Board of Governors in 1995 and 1996 and as a member of the Development Committee of the World Bank and the IMF, representing Chile, Argentina, Bolivia, Peru, Uruguay and Paraguay. In that capacity, Hon. Aninat was involved in the discussions on initiatives ranging from international policies for heavily-indebted poor countries to the proposals for reform of international financial architecture. More recently, Hon. Aninat served as Ambassador of Chile in Mexico, Director of the Center for Applied Globalization at Finis Terrae University, and as an international consultant to the Goldman Sachs Group.
- He also previously served in a range of economic positions in the Chilean Government; these included Chief Senior Negotiator for the bilateral Canada-Chile trade agreement, and Chief Debt Negotiator and senior advisor of the Central Bank of Chile and the Ministry of Finance. For 12+ years, he was a principal in Aninat, Méndez y Asociados, which was one of the largest consulting firms in Latin America. He advised a number of governments on matters ranging from tax policy to debt restructuring. Hon. Aninat was also the Latin American Coordinator for Harvard University's International Tax Program and has been a member of the Boards of Directors of several private companies and institutions in Chile and abroad.
- As President of the Social Equity Forum (SEF), which is under the sponsorship of the Inter-American Development Bank, he focused on bringing social equity concerns to the forefront of macroeconomic and sectoral policy debates to advance successful public policies in Latin America and throughout the Caribbean region. He has also served on the Board of Directors of ACCION International, which is one of the world's leading microfinance organizations and on the Board of Directors of the Institute of the Americas, which is dedicated to promoting economic growth through public-private partnerships in trade, infrastructure and investment.

LOU BLADEL is the Managing Director of Assurance services at Ernst & Young LLP and focuses on the Forensic & Integrity Service. With 26+ years in federal law enforcement, he brings a diverse skill set that he developed through his time serving the United States Marshals Service, Naval Criminal Investigative Service (NCIS) and the Federal Bureau of Investigation (FBI). Currently, he also consults with U.S. federal law enforcement agency directors, government regulators and key executives of Fortune 100 companies, Fortune 500 C-suite officials and boards of directors from across industry sectors on matters of economic espionage and insider threats. Most of his law enforcement career involved leading and investigating counterintelligence matters in the New York and Washington, DC, metropolitan areas.

Among his numerous leadership positions within the FBI, Mr. Bladel was special agent-in-charge of the New York office of the FBI's Counterintelligence Division, where he led the espionage/insider threat arrest and successful plea negotiations of an FBI employee. As chief of the FBI's Counterespionage Section, he led the espionage investigation of Edward Snowden. In 2013, he successfully testified before the U.S. Sentencing Commission to enhance the criminal penalties for theft of propriety information, and managed the DuPont economic espionage investigation, which resulted in the FBI's first-ever jury conviction for economic espionage. The case won the 2014 FBI Director's Award for Counterintelligence Excellence. Mr. Bladel also won the National Counterintelligence Executive Award for Community Excellence in leadership for his role in the FBI operation that led to the arrest and deportation of three Russian Intelligence Service illegals.





JOSÉ MORENO HERNÁNDEZ is an American engineer and a former NASA astronaut, who was assigned to the crew of Space Shuttle mission STS-128. He also served as chief of the Materials and Processes branch of Johnson Space Center. Mr. Hernández previously developed equipment for full-field digital mammography at Lawrence Livermore National Laboratory.

His final two years as a Lab employee he spent on assignment at DOE headquarters, working on the Materials Protection, Control and Accountability (MPC&A) Program, where he learned to speak Russian and made numerous trips to the former Soviet Union to help the United States negotiate purchases of nuclear material and help the Russians develop methods to protect their nuclear stockpile.

REAR ADMIRAL GARRY E. HALL USN (ret) received a political appointment to serve as a Senior Director on the National Security Council (NCS) and Special Assistant to the President for National Security Affairs. On the NSC he was responsible for Human Rights, Humanitarian Assistance, Immigration and Migration, Atrocity Prevention, United Nations Operations, Democracies, and Fragile States. In support of these portfolios, he led a team of career professionals dedicated to each of these functional areas.

A graduate of the United States Naval Academy he served 35 years on active duty. A naval aviator, he flew antisubmarine warfare helicopters and commanded two squadrons. Additionally, he commanded the capitol ship USS Tarawa LHA 1, which had a compliment of 1000 Sailors, 2000 Marines, 32 aircraft and 3 landing craft. As a Flag Officer he served as General Tommy Franks Information Operations Officer at the beginning of Operation Iraqi Freedom, served with NATO in the United Kingdom, commanded an Expeditionary Strike Group deployed to the Middle East, and led a Senior Service college at National Defense University. Admiral Hall holds a B.S. in Marine Engineering from the U.S. Naval Academy, an MBA from Southern Illinois University at Edwardsville, and is a graduate of National Defense University's Capstone Course.

Executive Vice President at Geocent; Former Director at NASA's Marshall Space Flight Center; former Director at NASA's Stennis Space Center; former COO at NASA's Michoud Assembly Facility









PATRICK SCHEUERMANN

PATRICK SCHEUERMANN is the former director of NASA's Marshall Space Flight Center in Huntsville, Ala. He headed one of NASA's largest field installations, with nearly 6,000 on- and near-site civil service and contractor employees -- including those at NASA's Michoud Assembly Facility in New Orleans -- and an annual budget of approximately \$2.5 billion.

Previously, he served as director of NASA's Stennis Space Center near Bay St. Louis, Miss. There, he implemented the agency's mission in the area of rocket propulsion testing; developed and maintained NASA's world-class rocket propulsion test facilities; and ensured Stennis continued to serve as the systems engineering center for the agency's applied science activities. He was also chief operating officer of NASA's Michoud Assembly Facility in New Orleans, where he was responsible for day-today management and operation and led the facility's recovery in the aftermath of Hurricane Katrina in 2005. From 1998 to 2000, Mr. Scheuermann served in Washington as a legislative fellow for U.S. Senate Majority Leader Trent Lott of Mississippi, as a participant in the Congressional Fellowship Program. From 1996 until his move to the nation's capital, he was chief of the New Business Office at Stennis, leading strategic investment planning and capability assessments for the center. From 1994 to 1996, he was project manager at Stennis for NASA's Reusable Launch Vehicle program, a NASA-industry effort to develop a new generation of rockets to safely and cost-effectively send payloads to space. He also served as project manager for the Evolved Expendable Launch Vehicle program, an effort led by the U.S. Air Force to build a family of expendable rockets that would reduce the costs of launching American payloads to space.

Mr. Scheuermann was project manager from 1991 to 1994 for the National Aerospace Plane project, a joint effort by NASA, the Department of Defense and industry to research and demonstrate hypersonic technologies for development of a single-stage-to-orbit vehicle capable of horizontal takeoff and landing and long-range, hypersonic flight within the atmosphere. He also was responsible for the design and construction of Stennis' E-2 Test Facility, a \$35 million test facility supporting materials development by subjecting test articles to extreme temperature conditions. From 1988 to 1991, Mr. Scheuermann was lead mechanical engineer for the National Launch System Program, a joint NASA and Department of Defense effort to develop a space transportation system to reliably and cost-effectively deliver a range of payloads to low-Earth orbit. His primary responsibility was overseeing construction of the E-1 Test Facility at Stennis. The \$150 million facility, originally designed for rocket engine component testing, conducts developmental tests requiring high pressure and high flow cryogenic fluids, hydrogen, oxygen, inert gases and industrial water. Mr. Scheuermann joined NASA in 1988 as a propulsion test engineer at Stennis, supporting testing of a developmental spacecraft propulsion system for NASA's Advanced Launch System/National Launch System programs. Prior to joining NASA, from 1986 to 1988, he was a space shuttle main engine test conductor for the Boeing Company in Bay St. Louis, Miss.

During his NASA career, Mr. Scheuermann has received numerous awards and honors. In 2006, he received NASA's Outstanding Leadership Medal for leading recovery efforts at Michoud following Hurricane Katrina. He received NASA's Exceptional Service Medal in 2001, cited for demonstrating substantial improvement in engineering, aeronautics, space flight and space-related endeavors. He received a Distinguished Alumnus Award in 2001 from the University of New Orleans. In 1998, he was a finalist in NASA's astronaut candidate selection program. He successfully completed the Senior Executive Service Candidate Development Program in 2005. A native of New Orleans, Mr. Scheuermann received a bachelor's degree in mechanical engineering in 1986 from the University of New Orleans. Scheuermann and his wife, the former Sarah Melissa Lee of Pearl River County, Miss., have a son and daughter, Chandler and Christina.

Assistant U.S. Attorney; Chief of International Narcotics, Money Laundering & Racketeering Section, CDCA U.S. Attorney's Office







CAROL ALEXIS CHEN, J.D.

CAROL ALEXIS CHEN, J.D., currently serves as Chief of the International Narcotics, Money Laundering, and Racketeering Section in the United States Attorney's Office for the Central District of California in Los Angeles, California. Ms. Chen is the rare federal prosecutor who has been an Assistant United States Attorney in both the Criminal and Civil Divisions over her fifteen years with the Department of Justice, with extensive criminal and civil trial experience. She has directed federal and local law enforcement in hundreds of federal criminal grand jury and wiretap investigations, evaluated investigations for federal prosecutions, and trained law enforcement agents as well as other prosecutors. She has won numerous awards and accolades, including from the Department of Justice and federal, state, and local law enforcement agencies, and was named by the Los Angeles County Bar Association, Criminal Justice Section as 2019 Prosecutor of the Year.

Ms. Chen has prosecuted some of the most significant cases of the Department, including multiple large-scale racketeering investigations targeting the Mexican Mafia and violent street gangs, such as the one for which she obtained, after a five-week trial, convictions and a life prison sentence for a Mexican Mafia member who murdered a rival and severely wounded an innocent bystander (nomination for the second-highest Department of Justice award pending); a large-scale, transnational money laundering case which was awarded another high-level DOJ award in 2018; and multiple large-scale transnational drug trafficking cases, including a 47-defendant prosecution targeting Mexican and Colombian drug cartel members and associates, with narcotics-based murder charges arising out of the torture, murder, and dismemberment of two victims. During the pandemic, she has been handling and supervising investigations related to scams and schemes perpetrated by criminals attempting to take advantage of COVID-19.

She has been an appointed member of various joint federal and local task forces and working groups, including serving as the Point of Contact for all of the California United States' Attorneys' Offices for the Joint Task Force – West Corridor ("JTF-W") and as a member of the Executive Board for High Intensity Drug Trafficking Area Joint Task Force ("HIDTA"). The task forces and working groups on which she actively participates are aimed at combating drug cartels, the drug trade, and transnational money laundering syndicates; the opioid epidemic; violent crime including that perpetuated by international organized crime groups and domestic street gangs; illicit firearms possession and weapons trafficking; and transnational border security threats. Ms. Chen has strong relationships with high-level career officials in different components of Main Justice, prosecutors in other United States Attorneys' Offices and in state and local prosecutorial offices, and various foreign law enforcement and prosecutorial partners. She collaboratively works with the leadership at all of the federal law enforcement agencies on both the regional and national levels as well as with the commanding officers at state and local police departments. Ms. Chen has front-line experience in addressing some of the most pressing crimes and criminal justice issues on multiple levels, including helping to devise and implement policies and setting investigative priorities as well as personally prosecuting the cases implicating them.

Since March, 2019, Ms. Chen has led the section which targets international and significant domestic narcotics trafficking and money laundering organizations; violent prison and street gangs; traditional and emerging transnational organized criminal enterprises, including those which utilize the dark net and cryptocurrency; and clandestine laboratories and "dirty doctors," pharmacies, and other street-level and wholesale distributors of opioids which cause serious bodily harm and death. She is the first female chief in the history of the section which was previously named the Organized Crime Enforcement Task Force ("OCDETF") Section and the Narcotics Section. Prior to her DOJ experience, Ms. Chen served as a judicial law clerk for two federal judges and was a litigator at one of the largest global law firms. She earned a Bachelor of Arts degree in Political Science from the University of California, Los Angeles, and a juris doctorate from Yale Law School.

ARNOLD A. SPENCER, J.D.

ARNOLD A. SPENCER is a former Securities and Exchange Commission (SEC) Prosecutor of the Year for the SEC's Southwest Region and currently serves as the general counsel of Coinsource, which is the largest Bitcoin teller machine company in the world.

He formerly served as First Assistant U.S. Attorney and Chief of the Criminal Division prosecuting cases involving securities and financial fraud, money laundering, environmental crimes, public corruption, healthcare fraud and immigration fraud. Mr. Spencer personally tried more than 20 jury trials involving securities and financial fraud and oversaw about 1,000 other convictions annually in his role at the U.S. Attorney's Office, including some of the fraud cases associated with the Enron scandals. He also chaired the Northeast Texas Securities Fraud Task Force and is a frequent speaker at national training seminars for experienced assistant U.S. attorneys and federal law enforcement agents.




