The campaign used explicit verbiage that suggests the receiver should vote for Lafonzo for CAC chair. According to the Code Annotated - Page 71 (Title VII Elections) definition of unsolicited-... "Any unrequested electronic message...for the purpose of explicitly requesting a vote or support." This further goes to show that instead of providing additional information about the candidate, the Lafonzo for CAC Campaign is actively requesting for votes. The verbiage suggests or insinuates to the receiver that they ought to perform an action which in this case is telling the receivers of the message to vote for Lafonzo for CAC Chair. As a result, this creates an ethical violation when a person sees this message and their actions that could come as a result from viewing this unsolicited page that they might have been subjected to without their consent. As per the definition of the term 'vote' according to Merriam-webster, "to express one's views in response to a poll especially : to exercise a political franchise." The CAC Chair candidate Louisa Lee's campaign manager sent unsolicited messages to multiple students saying "Hi {name} this is Zack! I'm using Remind to send important updates. Reply YES to this text now to avoid missing my messages for Louisa Lee for CAC." Many of the students felt uncomfortable and as if their privacy had been violated because they never opted in-to her texting system which has been marketed as optional to receive that first text. They never released their phone number or legal name to her or her team. They are also unsure of how their information was obtained leading to more questions raised by me and the students I am writing on behalf of.

### Additional Commentary by Petitioner

- Although she never asked for the support this is an unsolicited message
- I also am questioning how she received this personal information (Legal Names and Numbers) because several of the students who provided proof of receiving one of these unsolicited texts had their "Legal" names used when they have always been referred to different names. If they had gotten this information from friends or acquaintances of individuals it would have said their true name.
- It is different from a nickname because in both cases even their parents use their true name. They do not go by their legal first names.
- Unless they received this information from public records it is against the law because they never consented, it is a breach of privacy.
- The practice of "deadnaming" is making students feel uncomfortable and providing unnecessary trauma during a time like this.
- We have 7 confirmed cases that lead us to believe there are more.
