AS INTRODUCED

AS INTRODUCED

An Act to declare certain departments as in Good Standing, Bad Standing, or on Probation.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

Section 1: This act will be known as the Spring 2020 Departmental Status Act.

- Section 2: Purpose: To update Graduate Student Senate department status at the beginning of the Spring 2020 session.
- Section 3: AMENDATORY: For the purpose of this Act, departments continuing or newly classified as being in 'Bad Standing' will be found under the 'Bad Standing' column; departments continuing or newly classified as being on 'Probation' will be found under the 'Probation' column; and departments continuing or newly classified as being in 'Good Standing' will be found under the 'Good Standing' column.
