AS INTRODUCED

An Act of Procedure appointing the Chief of Staff of the Executive Branch; providing for short title, and providing for an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

**Section 1:** Title: This act shall be known and may be cited as “An Act Appointing the Chief of Staff of the Executive Branch of 2022.”

**Section 2:** Purpose: The purpose of this act shall be to appoint the Chief of Staff of the Lissau-Akuffo Administration within the Executive Branch.

**Section 3:** In accordance with the SGA Code Annotated §Title I, Chapter 2, Section 7b, which delineates the appointment process for the Chief of Staff position, the following student shall thus be appointed:

AS INTRODUCED

An Act adding a salary for the Graduate Student Senate  
Ways and Means Committee Chair, providing for  
increased retention and recruitment, providing for a short  
title, providing for codification, and providing an effective  
date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

**Section 1:** Title: This act shall be known and may be cited as the “SGA GSS WAM Chair Salary Addition Act of 2022”

**Section 2:** Purpose: The purpose of this act shall be to establish a salary for the Graduate Student Senate Ways and Means Chair for October and February during the fall and spring GSS Grant cycles.

**Section 3:** AMENDING: Title X, Chapter 5 of the Code Annotated in order to add the following position as a salaried position:

Graduate Student Senate Ways and Means Chair: \$350/Fall Grant Cycle, \$350/Spring Grant Cycle

- This stipend to be paid out at the end of October and February, corresponding with the deadlines for the Fall and Spring grant deadlines.
