Section 1: This act shall be known and may be cited as the "Auxiliary Allocation 4 Act of 2024-2025"

**Section 2:** PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.

**Section 3:** APPROPRIATION. The following amounts are hereby allocated to

Section 6: All unspent money remaining in the accounts listed in Section 3 shall revert to the SGA General Account after May 2, 2025, and the remaining appropriations shall be canceled.
