AS INTRODUCED

An Act of Legislation appointing the Chief of Staff of the Executive Branch; providing for short title, and providing for an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

- Section 1:** Title: This act shall be known and may be cited as the “The Chief of Staff Appointment Act of 2024.”
- Section 2:** Purpose: The purpose of this act shall be to appoint the Chief of Staff of the Glasscock-Mortazavi Administration within the Executive Branch.
- Section 3:** In accordance with the SGA Code Annotated §Title X, Chapter 5, Section 2, which delineates the appointment process for the Chief of Staff position, the following student shall thus be appointed:

- Section 4:** This act shall become effective when passed in accordance with the SGA Constitution.
