CONGRESSIONAL BILL CB-104-16 SENATE BILL GF20-07

#### AS INTRODUCED

An Act allocating office space in the Conoco Student Leadership Center for 2020-2021; providing short title; and providing an effective date.

# BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1:	Title: This act shall be known and may be cited as the "2020-2021 Conoco Student Leadership Center Office Allocations"
Section 2:	Purpose: This act shall allocate meeting spaces on the second and third floors of the Conoco Student Leadership Center of the Oklahoma Memorial Union for the 2020-2021 academic year;
Section 3:	All current office and common spaces will be converted to meeting spaces for all Registered Student Organizations (RSO) which can be reserved through Campus Scheduling;
Section 4:	RSOs who currently have their own offices will need to remove all items specific to that organization from that office by a specified date provided by the Student Government Association;
Section 5:	University of Oklahoma COVID-19 policy must be observed in all allocated spaces;
Section 6:	Reservations will be made and monitored through a platform exclusively accessible to RSOs;
Section 7:	RSOs may use offices on the second or third floor to host office hours, meetings, study sessions, interviews etc. within the hour(s) of their reservation;
Section 8:	RSOs may reserve an office during a given time period for the entire semester with one reservation;
Section 9:	Failure to adhere to the guidelines of the published allocation plan may result in removal of an RSO's reservation privileges and other possible sanctions;
Section 10:	Reservations will only be available to active RSOs as dictated by the office of
