Call to Order: 7:01 p.m.

Officer Reports:

- Chair: Some reminders: Probation is not supposed to be a punishment; you will retain good standing the current semester and the following semester. It is just to notify you to of your attendance, and help encourage continued attendance for all our senators. Feel free to contact us at any time with any questions, but we want to stress that probation does not affect your good standing status and ability to have departmental access to GSS grants. Bylaws, including attendance policy, are all on our GSS website and the executive committee is happy to address any questions and concerns.
- Vice-Chair: Sent out a feedback form on last email. If you're not getting emails let him know so he can add you. IF you had any ideas that you wanted to see happen or any idea on how to make improvements, and any ideas and feedback on how we can better run senate. He really encourages everyone to fill that out.
- Secretary: Reiterate what Carrie said. Probation does not affect access to grants and is supposed to be more of a heads up about attendance rather than a punishment. The goal of GSS is still to encourage inclusion and participation, so we're not trying to jeopardize that or be counterproductive to that goal. However, we do have to have standards. As the secretary, I am paid a stipend from SGA for my duties, which include keeping the minutes and tracking attendance. I don't do it to punish people, but it is what I am asked to do, so please don't get mad at me or the bylaws or the executive committee.

Committee Reports:

- Academic Affairs: Have a report! Reminder that outstanding grad student applications are due the 14th. Can be submitted in person or online (there is an online orgsync form)
- Development & Philanthropy: Have supply drive for local students. Flyers are available for this meeting, if people can take one and distribute to respective departments. Carrie has been requested to send flyer out to everyone if people have the ability to print and post around department or send to faculty and staff. They are the ones to help more since they have the funds to purchase supplies. This is a small drive, so anything big or littler will be helpful. That's all. - External Affairs: No report.
- Human Diversity: At this time, like to read a statement from Human Diversity committee in regards to budget bill that we'll be seeing tonight.
 - "Budgets and funding allocations reflect the values and principals of an institution. University of Oklahoma values inclusivity and community-building. Discrimination has no place on our campus. However, due to an unjust state law which binds our

hands as students and freely elected representatives, we cannot stop financial support to religious groups who discriminate. We are here to represent the whole of the student body of this university. We see these legal binds as an affront to our obligations to those we represent. We, therefore, condemn the discriminatory actions of which the fraternity, Brothers Under Christ, has and continues to use to negatively affect our fellow students. Furthermore, we condemn the unjust state law which forces us to pay for such discrimination. We have no choice but to fund this fraternity - to spend our fellow student's money on discrimination - to abandon our fellow student's rights - to fund against the principals upon which this university stands. But, make no mistake; we take this action with the utmost condemnation to the discriminatory practices taking place, as well as the written laws which deny our students their rights."

- Furthermore, we recommend that his bill pass, simply because there are numerous, dozens, of organizations, good organizations that don't discriminate that need their funding and we don't want to deny them their funding because of one discriminatory organization. The human diversity committee will be working on drafting a resolution about condemning the discriminatory actions of some student organizations and the state law that allows public funding to go to organizations with discriminatory values.
