If I do not receive a committee preference list from you, I'll assume you are willing to serve where you are most needed. I plan to have the committee assignments completed by the end of next week. Senators for whom we do not have new senator forms will be removed from the roster on the Friday before the next meeting so they are not bothered by an agenda email.
 - O We also have a new platform, Engage, which replaced Orgsync. A few of the senator memberships transferred over, but not all. I have only looked at Engage once thus far, but plan to make sure everything is set up there this week. I will likely unsub everybody for whom we do not yet have a senator form just so people who are no longer involved do not get bothered by announcements sent through there.
