- O Author: June 30th is the last date, any invoices have to be by then for Spring, and July 1st to December 31st for fall applications.
- o Senator DuBose (9): in the past June counted towards fall applications.
- O Author: yeah, we made that correction this year. We're grandfathering people in for this year. We are going to accept June expenses in the fall and the spring applications, because before it said June expenses counted for the fall.
- o Melissa: because before it was split 5 months (Jan through May expenses for Spring semester) and 7 months (June through December expenses for Fall semester)
- O Senator Rusmore (17): I think there's a typo in one of the travel awards. I think that should be Jessica Gardner
- O Author it goes out by their student ID, and I've copy and pasted what they put in their applications.
- O Senator Linsey (7): point of clarification, in the far right hand column, there's some decimal points that are missing and one extends after the decimal point.
- O Author: yeah, we updated it to round it up, because our calculation in Excel split it who got 100% and who got 75%. But we have updated it since then. And we rounded up.
