 - o Senator Delafield (111):
 - For Chair of the Graduate Student Senate, the nominee is Senator Burch (54).

 - o Candidate Addresses:
 - Senator Delafield (111): Senator Burch, you shall have five minutes to address the body of the Graduate Student Senate. Your time may not be extended.
 - Senator Burch (54): I am a first-year Ph.D. student in the Department of Geography. I have been a senator for two years. I bleive GSS has a lot of potential. With several of our ongoing initiatives, I would like ot continue supporting these initiatives and taking on new projects to advance GSS. I would love the opportunity to represent you all and to build awareness about GSS.

- GS21-32 Affirming Language in the Code Annotated Act of 2021
 - Motion to move GS21-32 to the floor by Senator Linsey (7), seconded by Senator Woodworth (108).
 - O Author, Mahak Merchant (Department of Inclusivity Director). Presented by Representative Caitlyn Harman (Human Diversity Committee Chair) and Representative Foster Hillis (Congressional Administration Committee Chair): The purpose of this legislation is to provide more inclusive language in the Code Annotated regarding the responsibilities of the Executive branch's Department of Inclusivity.

- GS21-29 Auxiliary Allocation 14 Act of 2020-2021
 - Motion to move GS21-29 to the floor by Senator Woodworth (108), seconded by Senator Linsey (7).
 - o Author, Lauren Patton (SGA Budget Committee Chair): The purpose of these pieces of legislation are to award auxiliary funding to various organizations listed within each bill.
 - O Yields time for questions. This will be the last auxiliary bill.

- GS21-39 Auxiliary Allocation 15 Act of 2020-2021
 - o No legislation presented. Item to be struck from the agenda.
- GS21-41 Senatorial Representation Clarification Act
 - o Motion to move GS21-41 to the floor by Senator Hamilton (82), seconded by Senator Mayer (27).
 - O Author, Dayten Israel (Graduate Student Senate Secretary): The purpose of this legislation is to amend the Bylaws of the Graduate Student Senate to clarify matters affecting representation, extending to: selection methods; policies and procedures for elections and appointments; and terms for senatorial representation. With the passing of our previous

legislation in this area, what is left with respect to the aforementioned is in disarray and confusion.

- o Yields time for questions.
 - Senator Linsey (7): What happens if a Department does not secure representation under the current one-month deadline?
 - Author: If a Department does not have representation by the deadline, the Department will forfeit representation. We currently have a policy of rolling acceptance, which complicates how we operate. This new deadline will give structure and reliability for us, and it will help us determine which Departments have representation earlier. We believe having a structured deadline will allow us to set better timelines for our meetings.
 - Senator Woodworth (108): Would you accept a friendly amendment to amend "called within one (1) month" to "reported to the Executive Committee of the Graduate Student Senate within one (1) month" in the relevant sections?
 - Author: Yes, I would.
 - Senator Mayer (27): What happens in the spring? Will there be a new round of elections or anything?
 - Author: No. The new terms for Senators will be for one (1) academic year. However, Senators can still resign, if they need to, and their Department can appoint another to continue the remainder of that term.
- o Senator Woodworth (108): Motion to Pass by Unanimous Consent
- o Seconded by Senator Wheaton (43).
- No objections.
- o Motion passes.
- GS21-42 Standing Committee Support Act
 - Motion to move GS21-42 to the floor by Senator Woodworth (108), seconded by Senator Wheaton (43).
 - Author, Dayten Israel (Graduate Student Senate Secretary): The purpose of this legislation is to amend the Bylaws of the Graduate Student Senate to provide defined responsibilities and revised policies affecting the various standing committees.
 - Yields time for questions.
 - Senator Rocha (53): Would you accept a friendly amendment to add a new statement to the "Committee Purpose" section and a new subsection to create a subcommittee that will focus on advising issue under the Academic Affairs Committee?
 - Author: Yes, I would.
 - Senator Woodworth (108): I am a part of the Ways and Means Committee, and we have our own internal policies that do not allow people to review applications from their Department. Would this still be the same under your new rules?
 - Author: Essentially, yes. The new rules are similar to those used by the SGA Budget Committee. However, these rules are the minimum, and the Ways and Means Committee can still create whichever internal conflicts rules it believes are necessary, which would include the rules the Committee currently has.
 - o Senator Rocha (53): Motion to Pass by Unanimous Consent
 - o Seconded by Senator Woodworth (108).
 - o No objections.
 - o Motion passes.
