Call to Order: 7:00 p.m.

Approval of the Minutes: Senator Walton (85), seconded by Senator Linsey (7).

Officer Reports:

- Chair:
 - Chair Mallick. Our previous chair has resigned, so our rules of succession have been triggered. • GS21-24 Oklahoma Data Privacy Resolution of 2021

- Author, Drew G. Brown (Undergraduate Student Congress Associate): The purpose of this legislation is to affirm that the University of Oklahoma Student Government Association supports the passage of Oklahoma House Bill 1602 in furtherance of the protection of individuals' data privacy. Data rights are human rights. States such as Oklahoma have taken steps to hold corporations for their violations of the International Bill of Human Rights.

This is a standard re-commitment to our previous statements and policies regarding this matter.

• GS21-26 Fail HB 2215 Resolution of 2021

- Author, Katie Beltz (Communications Representative) and Becca Yanez (Undergraduate Student Congress Associate): The purpose of this legislation is to affirm the University of Oklahoma Student Government Association's stance with respect to preservation of life and due process, as well as to urge the Oklahoma State Legislature to fail House Bill 2215. The bill we wish to fail belongs to a group of bills that would have a chilling effect on first amendment freedoms and values. We do not wish for an expansion of legal protections for those who harm individuals expressing their rights.

 - Senator Waterman (78): What is the chilling effect you mentioned?
 - Author: The bill itself would essentially allow individuals to harm protesters and later claim such protests were riots. There are already statutes available to protect rights of self-defense, and this legislation merely adds unnecessary protections that would really only harm individuals exercising their first amendment rights.
 - Senator Hamilton (82): The current bill reads differently than your interpretation. My understanding is that protections extend for those who unintentionally harm others due to a reasonable fear of harm caused by a riot. What is your impression based on this particular reading?
 - Author: In Undergraduate Student Congress, we discussed that there are pre-existing legal protections for self-defense. We do not wish to expand these protections, because it could harm first amendment rights in effect.

- Author, Joy Nath (Election Commissioner), presented by Cricket Kaya (SGA Chief of Staff): The purpose of this legislation is appoint a new member to the Election Commission. On behalf of Commissioner Nath: I apologize for my absence. We conducted an application and interview process. We graded candidates on a scale of 1-5. Of the seven application, four appeared for an interview. Ashley Marshall was the strongest applicant.

This legislation also condemns Matt Rowan's racist remarks about the Norman High basketball team, and it calls on Gaylord College of Journalism and Mass Communication to reaffirm and prioritize its commitment to fostering future generations of news media professionals who advocate on behalf of the marginalized and who will always speak up against bigotry if perpetuated by their colleagues.

- Senator Waterman (78): I would like to move to offer a hostile amendment to remove the kneeling references.
- Senator Shpeer (22): Seconded.
- Body enters a question period on the offered amendment to ask questions of the author of the amendment.
 - Author: This is a highly controversial issue that many oppose while others agree with. This is not the place for personal expression. I fully support the remainder of the bill.
 - Question to the author of the amendment:
 - Senator Rusmore (17): The Senator offers a good point in general, but the specific action that has incited this legislation requires context. Therefore, I believe the reference to kneeling should remain.
 - Senator Hunter (70): Regardless of how you feel about kneeling during the anthem, it is factually what happened.
 - Senator Hamilton (82): The right to kneel during the anthem is protected by the first amendment.
 - Senator Woodworth (108): I'm not finding this reference in the bill. (Vice Chair directed Senator Woodworth (108) to specific reference within the bill.)
 - Author: When something is written, it becomes a record of what we as a body support. Within the context of this bill, our reference to

kneeling during the anthem would serve as an approval of such actions and as a recognition by this body that such actions are a right.

- Senator Cone (13): At what point would you cutoff protected rights like that included in the whereas clause? Is there a line you are drawing that you would share with us?
- Author: I am not drawing a line. By putting it into writing, this body will be agreeing that kneeling is permissible.
- Senator Woodward (11): Giving the factual information is necessary to provide context to this bill.
- Author: What I am suggesting is merely part of the legislative function of this body, to not, as a body, recognize such actions as protected rights. We represent the entire graduate student population, and this issue is divisive.
- Senator Burch (54): Motion to move the previous question (to vote on the offered amendment).
- Seconded by Senator Tennell (37).
