- GF22-13 Confetti Makes Me Upsetti Bill
 - o Motion to move GF22 -13 to floor by Senator Gupta (67), seconded by Senator Norris (112)
 - Author (Congress Chair Lacey Lewis and Congress Sustainability Chair Rylee Houston): The purpose of this act shall be to amend the Student Government Association's Code Annotated to add confetti to the list of non-allowable items.
 - Yields time for question
 - O Senator Hamilton (81): Motion to pass by unanimous consent.

- GF22-14 Save Bedlam Act
 - o Motion to move GF22 -14 to floor by Senator Norris (112), seconded by Senator Hamilton (81)
 - Author (University College Representative Shrey Kathuria): The University of Oklahoma Student Government Association recommends that athletic departments and university officials the University of Oklahoma and Oklahoma State University work to maintain the Bedlam rivalry
 - Yields time for question
 - Senator Hamilton (81): Friendly amendment to say "rivalries" and spell out RSO
 - Author: accepts friendly amendment.
 - Senator Gibson (110): Will this cost OU more or less money?
 - Claire: we do not know, but if this passes that would definitely be figured out before it was implemented
 - o Senator Norris (112): Motion to pass by unanimous consent.

- GF22-15 Informed Voter Act of 2022
 - Motion to move GF22 -15 to floor by Senator Norris (112), seconded by Senator Hamilton (81)
 - Author (Associate Caleb Robinson and Congress External Affairs Chair Weslie Griffin): The University of Oklahoma Student Government Association discourages the use of straight ticket voting in the November 2022 General Election and promotes the use of well-informed voting practices in all future elections
 - Yields time for question
 - Senator Fogg (82): Do you know if this is representative of the student body?—are they unanimous in what we are asking with this?
 - Author: I talked with about 20 representatives and someone I know talked to 15 and they all agree
 - Senator Bruce (91): did you consider any possible pr issues with this bill due to the proximity of the midterm elections
 - Author: I did not because I do not see how this could be taken as partisan.

- Senator Bruce (91): Claire can you explain the logistics of what happens if this bill is signed
- Author: It likely will not even be printed until after the midterms. It also has already been picked up by the OU daily because a reporter goes into
- Senator Gibson (110): What impact would this bill have?
- Claire direct to Senator Hamilton (82): We did once have a resolution make it to the governor about masking, and I think one about critical race theory
- Senator Gibson (110): Specifically related to elections, is this really our place to be sending this?
- Claire direct to George: We do this a lot actually. You can also ask to send it back to committees or just vote not to pass it. I do think this is very normal for the senate.
- Senator Wilson (23): Can we not do a referendum since some people may not like this?
- The point of representatives is to amplify the voice of the student body. I do not know the details of a referendum
