• Sustainability:

- Senator Taylor (99):
 - Discussed doing a poll/survey about liter on campus with the Congress sustainability committee. The goal is to have the survey out next semester to help address issues on campus.
 - The chair of the Congress sustainability committee is planning to do a speaker series on environmentalism and Senator Taylor gave recommendations. The idea is to bring in a speaker each month.
 - The potential water bottle elimination bill research is going well, in addition to the compositing research.
 - We spoke about our water bottle elimination bill and organized ourselves to find where all water bottle refill stations are and to inspect the water filters. We will begin looking to see if there is someone to contact about water filters in poor condition. We also found many potential future collaborations that would be useful in eliminating the school's plastic and Styrofoam waste. This will give us an idea of how to cater our research to secure these collaborations/funding. On the composting bill, we also found programs that help eliminate waste in commercial kitchens. This will reduce waste that will go into composting and will save the university money. We looked as a group at other schools that are implementing both of these projects and began looking at how they started this work. We plan to message these schools to have a conversation on how to progress these correctly.
