- Chair:
 - Welcome to all of our new senators and welcome back to those of you who are returning! I am looking forward to getting to work with you all this year. Please don't hesitate to reach out to any of the Executive Officers if there is anything we can do for you at any point during the year.
 - o A few items to go through:
 - You are the representative for your department in the realm of graduate student concerns. While the Senate does not typically involve itself in department-specific issues, we encourage you to serve as advocates for your peers if difficult conversations need to happen. If you find that things are not getting solved at the department level, please come to us so that we can have a conversation about how to help. We want to make sure that graduate students feel like they are being heard, and you as a Senator are a huge part of making that happen.
 - With that being said, if your peers ever have questions about anything the Senate does or would like to see a bill or resolution presented, they should work with you to do so. For example, if your peers have any questions about the upcoming GSS grants, they should reach out to you first and you can then direct questions to our Ways and Means chair Bella. You are the first point of communication for your department for all Senate-related items.
 - Last year, our External Affairs committee distributed a survey to gauge the financial situation for graduate students on campus. I'm hoping that we can expand on this effort this year to compile a report to share with administrators which addresses many of the concerns graduate students face here on campus. Other universities have compiled similar reports or online documents, and I'm hoping to gather a few examples for us to work from. I think this will be an incredibly valuable precedent to create in the Senate, to hopefully work to compile this type of material more regularly and keep it updated.
 - As we prepare to enter the SEC in Fall of 2024, I'm really excited to share that our Senate leadership has been actively communicating with graduate student leadership at other SEC schools. Two years ago, Texas A&M graduate student leadership formed the SEC Graduate Leader Coalition, of which we have been a member of since its formation. For the past year, I have helped to lead the organization of our meetings, which typically happen every other month, and I look forward to sharing the data I gather from this group of leaders as we think of ways to continue to advocate for graduate students at OU. I've also been actively involved in a new Coalition that had formed to support the GRAD Caucus in the U.S. House of

- Representatives. Our Senate has historically not been very active in political advocacy, so this Coalition along with our collaboration with the SEC leaders offers an opportunity for our body to think about how we might begin to become more civically engaged as an organization.
- Lastly, and most importantly, I wanted to emphasize that you need to conduct yourself with decorum in these meetings. You are not only representing your department here but the entire graduate student body, so you should not take this opportunity lightly. These meetings are open to the public, and everything that is said goes in our minutes on the record. Please treat your fellow Senators and any guests with respect. If you have questions about legislation or disagree with the contents, we welcome open discussion, but in a way that respects all parties involved. Our authors have worked hard to bring forth the legislation they present here, and we want to be sure we recognize their effort and their point of view. Each and every senator comes to the Senate with a different set of life experiences, and that is what makes this Senate such a fantastic body. It is so important that we are kind to one another in all aspects of our operations.
