- Development & Philanthropy:
  - O Senator Morrison (122):
    - Working on fund raising with Equity Brewing company for GSS grants.

    - The first meeting will be in January. They will be GSS happy hours once a month that will lead up to the big fund-raising night later in the spring semester.
