- Academic Affairs: Approved the Outstanding graduate awards
- Development & Philanthropy: Nothing new to report No new candidates for 2023-24 identified
- External Affairs/Human Diversity: Went over the wages presentation and also decided Brian Carlton would be Chair and Ryan Beaty would be Vice Chair for next year.

- Internal Affairs: A lot of bill to go through. Mainly appointment bills that will go in a block. Talked about the objections that will be brought u on the primary funding act. There is also a parking appeals. There are a few other bills that the chair have no objections to. There is also a change to the code annotated and setting the next Red River Holiday. Last thing, a vote to overrule the SGA President, who wrote the legislation for an application for a undergraduate hire position. It was previously passed by both the Congress and Senate, but then VETO by the SGA President. This is for the leadership positions of the SGA branches.
- International Student Affairs: We received a total of 45 responses in regards to the international student survey, which is sufficient to fill the survey bank. Additionally, we are currently in the process of finishing up a linked group dedicated to connecting international students to employment opportunities

- Senator Hamilton (82): of our 12 organizations in the school of Law that requested \$77,000, only 10% of what they asked for was approved. This bill has 9 organization constituting 50% of the total monies allocated. I understand that sometimes you go based on money from the year before, but why is it that some organizations still do not see increases in their primary funding despite having consistent Aux funding requests, while other organizations receive the majority of the funds?
 - Author: We consider fiscal history and scope of the organization (how far they reach). Each organization this year received what they received the year before, and one organization getting more money would require other orgs to get less. Auxiliary funding is the superior way to obtain funding and organizations I have spoken to actually look forward to auxiliary funding.
 - Senator Hamilton (82): does auxiliary history factor into the next years primary funding?




Overview

- 47 different majors




Hardships Experienced This Year

 - Spending for technology




Sources of Income


988 choices selected



Current Financial Aid




Paying for Next Year's Education
