- Development & Philanthropy:
 - o Senator Morrison (122):
 - Planned first event: Food drive, details to come via PR.
 - Planned our first food drive. Bin pass outs will begin on October 18 at 2:00pm. The food drive will last 4 weeks, with one bin pickup halfway through. We also discussed setting up a table or booth on campus to collect food and raise awareness for the GSA. We also discussed hanging flyers on the South Research Campus and Main Campus for fundraising.

• External Affairs:

- o Senator Beaty (21):
 - The first thing we discussed was the name change from External Affairs to Internal Affairs and how we've swapped names. However, the primary focus of the meeting was discussing next steps putting together a report that can be presented to the graduate college, the Board of Regents, etc. about graduate student pay and how it measures compared to other schools within the conference. Additionally, the committee discussed how to put together a longitudinal mechanism that can be used between different areas of the university to look at issues facing graduate students and how the students are faring.

 - Discussed the upcoming name change for the internal affairs committee. Soon the internal affairs committee will be the External and Legislative Affairs Committee.
 - Selected a volunteer for the Graduate Council
- International Student Affairs:
 - O Senator Gupta (67):
 - Plans for academic year: addressing plans from last academic year and addressing issues faced by international students, including termination of international students.
 - The International Student Affairs committee recapped the last committee meeting, however, we had no set agenda because this was the first meeting. We want to be able to safeguard GAships so that in case of terminations. For the safeguard policy, we need reasonable time for contract termination and have an arranged fun for students who have lost GAships in the middle of the semester. We talked about improving the current LinkedIn group for international students and graduate students. We also briefly talked about a relocation fund.

• Sustainability:

- o Senator Taylor (99):
 - New projects and working on a shared resource for active projects. Meeting with Rylee Houston to collaborate with the SEC and SGA sustainability committee.
 - We spoke on the possibility of continuing the E-Waste bill and will have a concrete decision by the next meeting. We also brainstormed new ideas to work on throughout the year which included campus composting and attempting to end the sale of water bottles on campus. To make things easier for everyone, we did some housekeeping to keep documents and information organized and easily accessible. This also allows us to properly divide work to ensure we have an efficient workflow and are not repeating tasks.

■ The WAM committee selected October 20th as the deadline to submit GSS grant applications. The online application is expected to be made publicly available on September 22nd. Grading of GSS applications will be completed either on the weekend of October 27th or November 4th. The Grading date for applications is expected to be selected by next meeting. Lastly, the committee reviewed the final versions of the research and travel electronic grant forms.

Student Concerns

Special Orders:

- Dean Hewes, Graduate College:
 - Graduate College takes care of the administrative duties for all graduate students on the OU Norman campus except the law school.
 - The Graduate College also supports and advocates for graduate students and acts as a central hub for graduate student education and student life.
 - Rolled out a welcome portal for newly admitted students
 - When students are admitted to OU, they receive an email that directs them to the poral with a video and additional information to help students navigate the process of starting at OU, including setting up email accounts, FAFSA, and obtaining a Sooner card.
 - Working towards developing an electronic system that shows degree requirements and progress made toward degrees. The system also contains the possibility for mapping degree paths that can be individualized by students and a planner for mapping out student schedules.
 - This year the Graduate College just completed a final step for graduate assistants to cut fees and cut them by \$1700 per year for graduate assistants starting this fall. Overall, fees have been cut by close to \$4000 per year. Now the graduate college is working towards increasing graduate stipends.
 - On the Graduate Survey (GradSERU), they reported excellent responses and the graduate college has excellent ideas of ways to address student concerns and improve graduate student life at OU. Of all the schools in the consortium ~14 schools) OU had the best response rates.
