 - O Given that we are quickly approaching the end of the semester, it is time to open up nominations for the 2023-2024 Executive Office positions. Any current senator can nominate another senator for an executive position; an individual cannot nominate themselves. The nominator must submit this Engage form, which will then be sent to the nominee for final approval. We will be meeting with the Graduate College deans next Tuesday and will provide a report from that meeting on our March 9th General Assembly meeting. - Academic Affairs: We discussed the outstanding student award flyer and application
- Development & Philanthropy: Mid-March(?) for Big Event Registration
- External Affairs: we discussed the distribution of our survey and talked about comparing our results to other universities in the area.
- Internal Affairs: Couple of different updates: Dean Wrobel is coming to talk about HLC accreditation update. Two of our (IA) bills are coming through, Jordan cannot vote because she is the author. One will have to go to roll call (the expulsion bill). I (Tom Hamilton), will call for it. Revision of the Crimson Life Ass. and it is going through our Senate just out of procedural grounds.

Got a non recommendation (not needed). Also, all of the appointments did not have a recommendation, and they were moved in bulk. There are three others bills that are getting pushed through in regards to new laws. Specifically, gender-affirming issues and LGBTQ+, with the friendly amendments. Discussed the Safety bill and the new improvements. Emily will likely give a new introduction to the student body. It is good to go. Final bill is an aux bill. No issues there. Elections are coming up. Cooper is not going to run for secretary, meaning that Jordan will need to have help running the election if she is going to run. We all need to prepare to assist, if needed. Jordan will let us know.

- International Student Affairs: We are getting ready to announce a survey for international students to the general body. The survey does address issues including, but are not limited to: food insecurity, transportation, discrimination and employment related issues.
- Public Relations: In-person meeting achieved. Re-addressed the goals of the committee Discussed the needs of the external affairs committee for their PR. Called for volunteers for External Affairs graphics Discussed more ideas for social media outlet posts
- Sustainability: A new secretary was elected, Caden Smith. New members were introduced to the committee. The minutes from the last session of Fall 2022 were reviewed for new members. We elected new members to work on the e-recycling bill proposal.
