- **Communications:** My assistants are doing a great job. We are organizing our first event on October 29. Sabrina is doing a great job posting on social media. Josh is redesigning the newsletter to be more attractive. Gabi is ready to make any graphic and is planning the Congress apparel.
- **Congressional Administration:** We saw CB-100-27 about redistricting which got a rec of do pass. CB-100-28 also got a rec of do pass. This just mandates that the polling online should be open for 12 hours, and not closed early. We have also each chosen topics for the Code Cheat Sheets. We have some constitutional amendment ideas from Dan and Gabi as well.
- **External Affairs:** We finished our Voter Registration Drive push from before midterms last week. We talked about finishing the absentee ballot information packets for all 50 states and other countries. We're now working on figuring out what our members want to do next.
- **Human Diversity:** We saw CR-100-11 which was very good but very contentious. We had members with different viewpoints and we saw several amendments in committee. We gave that bill a rec of do pass. I personally presented to NAACP and Black Student Association last week. What I understood from them is that there is a lack of communication between Congress and these groups. I invited them to Congress to express their feelings. I think that they were encouraged by this, so hopefully we see them more often. My members are also working on speaking to different professors about speaking in their classes, and there will be a bill about the Campus Climate Board soon. We will also be working with IAC, NAACP, and BSA on doing mixers.
- **Problems and Projects:** We spoke about our two upcoming events. We pushed Turn Up for Transit to November 7 from 11:00am-1:00pm. Problems, Projects, and Puppies is tentatively scheduled for November 2. Shannah has been in touch with the city about the Lindsey and Elm intersection, and the city's traffic department will get back to her this week. Caroline is going to handle the blue light situation. My Vice Chair made a contact folder for members of Problems and Projects to use in the future.
- **Sustainability:** My Secretary asked about Greek recycling since it's cheap and they have huge budgets. Josh Miller is still working on the Bike Event, and that will likely be next semester. Gina is

still working on her event for October 24, so please bring t-shirts if you have them. Ian Stone thought about more places to put water fountains on campus. We might work with Problems and Projects on this, Hobson is working with OU printing about the green funding for RSOs. Richard came to our meeting today to talk about printing agendas for the general meetings and hopefully wasting less paper. Alan's composting project will be taken over by me, and Matt's project is being handled by Josh.

- **University Policy:** We talked about the course evaluation project and talking to faculty members about the role of evaluating teachers in the educational process. They want to see what these evaluations effect. They are already compiling their data for this resolution. They are looking at the Food Recovery Network and getting an advisor for that student group. They are working in the Department of Environmental Science. I gave them Emma's contact info. They are basing a lot of their policy for this on OSU's food waste policy. They also have the compiled emergency number hotline project which has met a lot of opposition from the administration. The administration wants Trey to poll the idea with students including what situations they would use it, whether they would like it. He also needs to see what the cost would be and what departments' requirements would look like.
- **Ways and Means:** We funded eight organizations and denied one. We spent about \$8,000. We also passed a Congressional Initiative Funding Bill for buying blue books and scantrons, although they want the correct scantrons this time.

An Act relating to the Fall 2018 General & Run-Off
Elections, providing for a short title, providing for
codification, and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

Section 1: Title: This act shall be known and may be cited as the “Polling Location Act of Fall 2018”.

Section 2: Purpose: The purpose of this act shall be to designate polling locations for the Fall 2018 General & Run-Off Elections.

Section 3: In accordance with Title VI, Chapter 2, Section 14 of the SGACA, “*The number and location of the polling places shall be established by an Act of the Legislative Branch,*” the following polling locations are established for the Fall 2018 SGA General Elections (October 30 and October 31) and reserved for a potential run-off election (November 6):

- Couch Restaurants
 - Outside the entrance nearest Couch Tower
- Dale Hall
 - Outdoors within twenty (20) yards of the main entrance
- Devon Energy Hall
 - First Floor Atrium
- Innovation Hub
- Oklahoma Memorial Union
 - First floor area near the IT store and radio station

A Congressional Act authorizing the use of the Congressional Initiative Fund in order to purchase of testing materials for students, providing for a short title, providing for codification, providing an effective date, and providing for distribution.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: Title: This act shall be known and may be cited as the “Testing Materials Accessibility Act of 2018.”

Section 2: Purpose: The purpose of this act shall be to provide examination green books and Scantrons for the OU student body to use for any test they may have. These green books and Scantrons will be made available in the Student Government Association Office in the Archie Dunham Conoco Student Leadership Center.

The cost breakdown is as follows:

1500 8.5”x11” Roaring Spring Green Books at \$0.45 per book
1500 7”x8.5” Roaring Springs Green Books at \$0.35 per book
3000 Scantron forms at \$.30 per form
8.75% sales tax

Total: \$2,283.75

Section 3: The Undergraduate Student Congress hereby authorizes the purchase and delivery of 3000 examination green books and 3000 Scantrons to be purchased, at a cost of \$2,283.75 to the Congressional Initiatives Fund, and distributed in the SGA office.

AS INTRODUCED

A Congressional Act amending districts per reapportionment, providing for a short title, providing for codification, and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

Section 1: Title: This act shall be known and may be cited as the “The Redistricting Act of 2018.”

Section 2: Purpose: The purpose of this act shall be to reapportion districts.

Section 3: AMENDATORY: All additions are marked with an underline and all deletions are marked with a strikethrough. Section V of the Bylaws is amended to read:

Section 4.1: STUDENT CONGRESS DISTRICTS

1. Pursuant to Article III, Section 2 of the SGA Constitution, Student Congress is divided into sixteen (16) districts apportioned on the basis of academic interest. Changes to these districts must be approved by a three fourths (3/4) majority of the total membership of Congress. In the circumstances that a new major is added between redistricting cycles, it shall be the Congress Chair’s responsibility to decide where it will be sorted until the next even number year.

2. The districts and their compositions are as follows:

a. ARCHITECTURE District: Shall consist of all students in the College of Architecture. This district has one seat.

b. ATMOSPHERIC AND GEOGRAPHIC SCIENCE District: Shall consist of all students in the College of Atmospheric and Geographic Science, and all students with declared majors in the following Arts and Sciences Departments: Interdisciplinary Perspectives on the Environment Program. This district has one seat.

~~e. BIOLOGY District: Shall consist of all students with declared majors of the following College of Arts and Science program: Biology.~~

c. FINANCE District: Shall consist of all students with declared majors in the Michael F. Price College of Business in Finance, International Business, and General Management. This district has two seats.

~~d. BUSINESS District: Shall consist of all students with declared majors in the Price College of Business.~~ Shall consist of all students with declared majors in the Michael F. Price College of Business in Economics, Accounting, Energy, Management Information Systems, Marketing, Sports Managements, and Supply Chain Management. This district has four seats.

e. COMMUNICATION District: Shall consist of all students with the declared majors in the Gaylord College of Journalism and Mass Communication (including pre-Journalism) and declared majors in the following Arts and Sciences Departments: Communication ~~and Human Relations.~~ This district has three seats.

f. EARTH AND ENERGY District: Shall consist of all students in the College of Earth and

Energy. This district has two seats.

g. ~~EDUCATION INTERPERSONAL STUDIES~~ District: Shall consist of all students in the College of Education and all students with declared majors in the following Arts and Sciences Departments: ~~Library and~~

~~Information Studies, Human Relations and Social Work, all students in the University Outreach College of Continuing Education, and the College of Liberal Studies.~~ This district has one seat.

h. ENGINEERING District: Shall consist of all students in the Gallogly College of Engineering. This district has five seats.

i. FINE ARTS District: Shall consist of all students in the College of Fine Arts and all students with declared majors in the following Arts and Sciences Departments: Film and Media Studies. This district has two seats.

j. HUMANITIES District: Shall consist of all students with declared majors ~~of Undecided and declared majors~~ in the following Arts and Sciences Departments: African and African American Studies, Anthropology, Classics and Letters, English, History, History of Science, Native American Studies, Philosophy, Religious Studies, Women's and Gender Studies, and Library and Information Studies. This district has three seats.

k. INTERNATIONAL STUDIES District: Shall consist of all students with declared majors in the College of International Studies and all students with declared majors in the following Arts and Sciences Departments: Interdisciplinary Studies of International Relations Program. This district has one seat.

l. LANGUAGE District: Shall consist of all students with declared majors in the following Arts and Sciences Departments: Modern Languages, Literature, and Linguistics. This district has one seat.

m. LIFE SCIENCE District: Shall consist of all students with declared majors in the following Arts and Sciences Departments: Microbiology and Plant Biology ~~and~~, Health and Exercise Science, and Biology. This district has four seats.

n. PHYSICAL SCIENCE District: Shall consist of all students with declared majors in the following Arts and Sciences Departments: Astronomy, Chemistry/Biochemistry, Mathematics, and Physics. This district has two seats.

o. SOCIAL SCIENCE District: Shall consist of all students with declared majors in the College of Liberal Studies and in the following Arts and Sciences Departments: Economics, Political Science, Psychology, ~~Social Work (including pre-Social Work)~~, and Sociology. This district has four seats.

p. UNIVERSITY COLLEGE District: Shall consist of all students in the University College, including second year pre-Health Science Center students, Early Entry Students, all students with declared majors of Undecided, all students in the University Outreach College of Continuing Education, and all students with declared majors in the following Arts and Sciences Departments: Multidisciplinary Studies. This district has twelve seats.

3. Representatives shall vacate their seat when they become ineligible to run or vote in their district.

a. Exceptions:

i. Students elected to represent the University College District during their freshman year may retain their seat until the end of their electoral mandate.

Section 4: This act shall become effective at the beginning of Congress Session 101.

AS INTRODUCED

An Act amending the SGA Code Annotated to clarify polling times for SGA sponsored elections, providing for a short title, providing for codification, and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

- Section 1:** Title: This act shall be known and may be cited as 'The Polling Clarification Act of 2018.
- Section 2:** Purpose: The purpose of this act shall be to amend the Code Annotated in order to codify traditional polling times.
- Section 3:** For the purposes of this legislation, all additions shall be marked with an underline and all deletions shall be marked with a strikethrough.
- Section 4:** Title VI, Chapter 2, Section 14 of the Code Annotated shall be amended as follows:

14. Polling

The number, hours of operation, and location of physical polling places shall be established by an Act of the Legislative Branch at least three (3) academic weeks before each election. Students of any district may vote at any poll. The number of poll operators, polling machines, and computers at each poll shall be established by the Election Chair with regard to the number of voters expected at each polling location. Students may vote on any computer with internet access to the election website, which shall be administered by the University of Oklahoma Information Technology (OU IT) and the SGA Election Staff. Neither OU IT nor the SGA shall be responsible for ensuring that non-OU IT or SGA computers have access to the election website.

There shall be at least one (1) poll operator at each poll at all times during voting hours. ~~For any general election, polling shall take place from 9:00 a.m. to 9:00 p.m. on at least one day of the election.~~ For elections which last two (2) days, online polls shall open at 9:00am on the first day and remain open until 9:00 pm on the second day. For elections which last one (1) day, online polls shall open at 9:00 am and close at 9:00 pm. Additional polling times may be established by an act of the Legislative Branch. Every student voter must provide their OU NetID and Password identification on the election site to verify his or her identity to the election staff. The order of candidates' names on the ballot shall be determined by a raffle done by the Election Board.

Section 5: This act shall become effective when passed in accordance with the SGA Constitution.

CONGRESSIONAL RESOLUTION CR-100-11

AS INTRODUCED

A Resolution advocating for the rights of students who have experienced sexual misconduct, discrimination, and harassment and requesting that the University of Oklahoma administration review, address, and expand its current policies regarding sexual misconduct, discrimination, and harassment; and providing for distribution.

Whereas: The Undergraduate Student Congress serves as the elected voice of undergraduate students at the University of Oklahoma; and,

Whereas: Students at the University of Oklahoma have reported incidences of sexual misconduct, discrimination, and harassment perpetrated against them by faculty, staff, donors, and other members of the University community; and,

Whereas: Students have a right to an educational environment without sexual misconduct, discrimination, and harassment; and,

Whereas: It is the responsibility of the University administration to ensure that students' complaints of sexual misconduct, discrimination, and harassment are dealt with swiftly, free from the fear of retaliation for reporting; and,

Whereas: All members of the University community should be held to the same standards of behavior, regardless of status as high-level administrative officials, tenured faculty, donors, or others of elevated or protected status; and,

Whereas: The student experience depends, in part, on the ability of students to trust in the University to investigate and handle complaints against it; and,

Whereas: According to the University of Oklahoma Investigative Process for Internal Complaints under the Sexual Misconduct Discrimination and Harassment Policy¹, University administration has the power to take immediate, appropriate, and unilateral administrative or disciplinary action deemed necessary for the welfare or safety of the University community; and,

Whereas: This policy applies to all University students, faculty and staff, visitors, contractors, applicants for admission to or employment with the University, as well as University affiliates, donors, and others conducting business on campus; and,

Whereas: The University considers almost all employees, with the exception of those designated confidential, as Mandatory Reporters. When an employee becomes aware of an alleged act of sexual assault, stalking, dating or domestic violence, sexual harassment, or gender discrimination, the employee must promptly share the information with the appropriate administrative entities as outlined by the Institutional Equity Office of the University of Oklahoma²; and,

Whereas: The burden falls upon the University administration and leadership to earn the trust of the student body.

NOW, THEREFORE, BE IT RESOLVED BY THE UNDERGRADUATE STUDENT CONGRESS THAT:

Section 1: In order to reduce instances of sexual misconduct, discrimination and harassment within the University community, University of Oklahoma administrators should enforce a robust Title IX policy that is followed by all administration and implemented equitably. This policy should promote ease of reporting, demonstrate understanding of the difficulties faced by victims of sexual misconduct, discrimination, and harassment, and reflect a no-tolerance policy regarding such behavior from members of the University community.

Section 2: Without infringing upon the right to academic freedom and expression, the University of Oklahoma should more fully enforce its existing policy to investigate and respond to employees and University officials who suppress or dismiss reports of sexual misconduct, discrimination, and harassment, especially if the individuals are Mandatory Reporters.

Section 3: The University of Oklahoma should establish a policy and protocol for thoroughly investigating allegations of sexual misconduct, discrimination, or harassment by members of the University community with elevated or protected status, such as high-level administrative officials, tenured faculty, donors, et cetera.

Section 4: The University of Oklahoma administration should be unequivocal in its support for individuals who have experienced sexual misconduct, discrimination, and harassment on its campus and within its community.
