CONGRESSIONAL RESOLUTION CR-100-12

AS INTRODUCED

A Resolution Recognizing Girls in Aviation Day; and  
providing for distribution.

Whereas: The aviation and aerospace industries contribute greatly to the economy of the State of Oklahoma; and

Whereas: The aerospace industry is dependent upon a skilled workforce, including trained college graduates; and

Whereas: Since 1947, the OU Aviation Program has prided itself on providing students with quality aviation instruction paired with a solid business foundation from a nationally ranked institution; and

Whereas: During the last two decades, although the number of women involved in the aviation industry has steadily increased, only 16 percent of people working in the aircraft, spacecraft, and manufacturing industry are female<sup>1</sup>; and

Whereas: Girls in Aviation Day exists to celebrate the contributions of women in the field of aerospace and aviation, including Lillian Todd, who designed and built aircraft in 1906; Harriet Quimby who, in 1911 became the first woman to earn a pilot certificate and cross the English Channel; Bessie Coleman, who was the first Native American and African American to obtain a pilot's license in 1921; Helen Richey, who became the first woman pilot for a U.S. commercial airline in 1934; Astronaut Dr. Sally Ride who, in 1983, was the first American woman in space; Jeana Yeager who copiloted the first non-stop, nonrefueled flight around the world in 1986; Astronaut Eileen Collins, who became the first female Space Shuttle Pilot in 1997 and first female Space Shuttle Commander in 1999<sup>2</sup>; and

Whereas: Girls in Aviation Day also serves to encourage and inspire girls to pursue careers in aviation and aerospace through exposure to STEM curriculum and positive female role models.

NOW, THEREFORE, BE IT RESOLVED BY THE UNDERGRADUATE STUDENT CONGRESS THAT:

**Section 1:** The Undergraduate Student Congress recognizes October 13, 2018 as Girls in Aviation Day and encourages students to support and participate in the events being held on our campus to commemorate this day.

AS INTRODUCED

An Act relating to the Fall 2018 General & Run-Off  
Elections, providing for a short title, providing for  
codification, and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

**Section 1:** Title: This act shall be known and may be cited as the “Polling Location Act of Fall 2018”.

**Section 2:** Purpose: The purpose of this act shall be to designate polling locations for the Fall 2018 General & Run-Off Elections.

**Section 3:** In accordance with Title VI, Chapter 2, Section 14 of the SGACA, “*The number and location of the polling places shall be established by an Act of the Legislative Branch,*” the following polling locations are established for the Fall 2018 SGA General Elections (October 30 and October 31) and reserved for a potential run-off election (November 6):

- Couch Restaurants
  - Outside the entrance nearest Couch Tower
- Dale Hall
  - Outdoors within twenty (20) yards of the main entrance
- Devon Energy Hall
  - First Floor Atrium
- Innovation Hub
- Oklahoma Memorial Union
  - First floor area near the IT store and radio station

**Section 4:** This act shall become effective, while in accordance with the SGACA, immediately following passage and approval.

AS INTRODUCED

An Act relating to appropriations; providing for short title; stating purpose; appropriating Auxiliary Funding for the 2018-2019 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

**Section 1:** This act shall be known and may be cited as the “Auxiliary Allocation 06 Act of 2018-2019”

**Section 2:** PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.

**Section 3:** APPROPRIATION. The following amounts are hereby allocated to

**Section 6:** All unspent money remaining in the accounts listed in Section 3 shall revert to the SGA General Account after May 3, 2019, and the remaining appropriations shall be canceled.

**Section 7:** This act shall become effective when passed in accordance with the SGA Constitution.
