BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

- Section 1:** Title: This act shall be known and may be cited as the “Testing Materials Accessibility Act of 2019.”
- Section 2:** Purpose: The purpose of this act shall be to provide Scantrons for the OU student body to use for any test they may have. These Scantrons will be made available in the Student Government Association Office in the Archie Dunham Conoco Student Leadership Center.
- Section 3:** The Undergraduate Student Congress hereby authorizes the purchase and delivery of 6000 Scantrons to be purchased, at a cost of \$1,119.38 to the Congressional Initiatives Fund and distributed in the SGA office.
