CONGRESSIONAL BILL NO. 960110

AS INTRODUCED

A congressional act amending Title XII Finances,
Chapter 4 Finances of the Code Annotated, providing
for a short title, providing for codification, and
providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

- Section 1:** Title: This act shall be known and may be cited as “An Act Revising the Budgetary Process”
- Section 2:** The purpose of this act shall be to strike all rules, guidelines, regulations regarding the requirement of interviews during all of the Student Government Association Budgetary Committees funding processes.
- Section 3:** Striking Title XII- Finance, Chapter 4- Budgetary Process, Section 20: Primary Budget Process, Section A Eligibility, IV Interview Enforcement:
~~“iv. Interview Enforcement: Any organization who schedules an interview but fails to send a representative to that interview shall be ineligible for funding at the discretion of the Chair of the SGA Budgetary Committee; this decision is subject to reversal by the majority of the SGA Budgetary Committee.”~~
Replace Title XII- Finance, Chapter 4- Budgetary Process, Section 20: Primary Budget Process, Section A Eligibility, IV Budgetary Form Requirement:
iv. Budgetary Form Submission Requirement: Organizations are required to fill out the supplementary Budgetary Form on OrgSync whenever they submit a budget for funding. Upon review of an organizations budget and budgetary form, if the SGA Budgetary Committee has any further questions or concerns they may email the organization for clarification. The creation of the SGA Budgetary Form shall be left up to the discretion of the SGA Budgetary Committee.”

Striking Title XII- Finance, Chapter 4- Budgetary Process, Section 20: Primary Budget Process, Section B Timeline Roman Numeral III Interview Scheduling Deadline and Enforcement:

~~“iii. Interview Scheduling Deadline and Interviews: The Chair of the SGA Budgetary Committee shall determine the specific time, date, location, and method the interview schedule is due.”~~

Replace Title XII- Finance, Chapter 4- Budgetary Process, Section 20: Primary Budget Process, Section B Timeline Roman Numeral IV, Budgetary Form Submission Requirement:

iv. Budgetary Form Submission Requirement: Organizations are required to fill out the supplementary Budgetary Form on OrgSync whenever they submit a budget for funding. Upon review of an organizations budget and budgetary form, if the SGA Budgetary Committee has any further questions or concerns they may email the organization for clarification. The creation of the SGA Budgetary Form shall be left up to the discretion of the SGA Budgetary Committee.”

Striking Title XII- Finance, Chapter 4- Budgetary Process, Section 21: Auxiliary Budget Process, Section B Funding Requirements, III Interviews:

~~“iii. Interviews: Each organization must send at least one student representative to their scheduled emergency allocations interview. Failure to attend will result in an ineligibility from receiving auxiliary funding for a period of three (3) weeks. If extenuating circumstances arose, the Chair of the SGA Budgetary Committee must be notified in writing by 5:00pm the next business day following the scheduled interview time. The SGA Budgetary Committee as a whole will review the request to determine if funding will be granted.”~~

Replace with: Title XII- Finance, Chapter 4- Budgetary Process, Section 20: Primary Budget Process, Section A Eligibility, IV Budgetary Form Requirement:

“iv. Budgetary Form Submission Requirement: Organizations are required to fill out the supplementary Budgetary Form on OrgSync whenever they submit a budget for funding. Upon review of an organizations budget and budgetary form, if the SGA Budgetary Committee has any further questions or concerns they may email the organization for clarification. The creation of the SGA Budgetary Form shall be left up to the discretion of the SGA Budgetary Committee.”

Section 4: This act shall become effective when passed in accordance with the UOSA Constitution.

AS INTRODUCED

Section 7: This act shall become effective when passed in accordance with the SGA Constitution.
