CONGRESSIONAL BILL NO. 980128 SENATE BILL NO.

#### AS INTRODUCED

An Act establishing the Student Environmental Coalition, providing for a short title, providing for codification, and providing an effective date.

#### BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

- **Section 1:** This act shall be known and may be cited as the "An Act Establishing the Student Environmental Coalition".
- **Section 2:** The purpose of this act shall be to establish the Student Environmental Coalition.
- **Section 3:** For the purposes of this legislation, all addition shall be marked with an <u>underline</u> and all deletions shall be marked with a <u>strikethrough</u>.
- **Section 4:** Amending Title XI SGA Boards, Committees, and Commissions of the Code Annotated and establishing:

#### **Chapter 8- Student Environmental Coalition**

#### 39. Delegation Purpose

The SGA Student Environmental Coalition, "SEC," will ensure that various environmental groups communicate well to accomplish goals in the most effective way possible and serve as environmental advisors to the campus at large.

#### 40. Membership Requirements and Responsibilities

All students currently enrolled at the University of Oklahoma shall be eligible to submit applications. These applications shall be reviewed and interviews shall be held by the executive members. Students must remain in good standing with the University.

#### 41. Officers

The officers of the organization shall be Chair, Vice-Chair, Communications Director, and Secretary.

#### a. Eligibility

Members of SEC in good academic standing will be eligible to run for office; the chair of SEC must have adequate time to devote towards stewarding the council.

#### b. Selection

SEC Officers will be elected by a majority vote of current SEC members.

#### c. Term Length and Limit

All SEC officers will be elected for one academic year.

#### d. Responsibilities

The Officers will work closely with the SGA and, most importantly, the various Registered Student Organizations related to Environmental Sustainability to ensure the mission of SEC is actualized.

#### e.Vacancies

If a vacancy arises, an ad-hoc election will be held for the corresponding position. Until that election is held, the position immediately subordinate (Descending from Chair to Vice-Chair to Secretary to Director of Communications) will serve as the interim officer; if the Secretary resigns, the Director of Communications will assume those responsibilities.

#### f. Officer Removal

The SEC shall have the authority to remove an officer with a simple majority with the advice and consent of the legislature.

#### 42. Internal Proceedings

The Student Environmental Coalition shall establish rules of procedure for the internal operations for the organization. These rules shall be published and available to students upon request. Any proposed and adopted rule changes must be sent to the SGA President, Graduate Student Senate Chair, Chair of the Undergraduate Student Congress, and Campus Activities Council Chair

#### 43. Meetings

#### a. Meeting Times:

The Chair of the SEC shall establish meeting times for the full academic year by the third academic week of the fall semester. The meetings shall be open to the public and are subject to the Oklahoma Open Meetings Act.

#### b. Attendance:

Members will be allowed two excused absences (outside of academic obligations) with prior notification to Chair or Vice-Chair. An unexcused absence without notification will count as a strike, and after three strikes the membership will be under review.

44. Power and Authority
The SEC shall be empowered to create any such committees, boards, commissions, or other such entities that it deems are necessary to further its purpose.

#### 45. Funding

The SGA Student Environmental Coalition shall be provided financial support through the Executive **Branch** 

#### 46. Student Advisement

The SEC shall report to the SGA Vice President for advisement on major initiatives or changes.

#### AS INTRODUCED

An Act of Procedure Expelling Members of Congressional Session 98 for excessive absences; providing for a short title; stating purpose; and providing an effective date.

Section 1:	Title. This act shall be known as "An Act Expelling Session 98 Representatives"		
Section 2:	Purpose. The purpose of this act shall be to expel a member for excessive absences. Because John Grunewald and Jon Yawn have accrued excessive unexcused absences and have failed to petition the Executive Committee for an attendance waiver, and as a result have failed to represent their constituents, the membership of the aforementioned is pending expulsion.

#### CONGRESSIONAL BILL NO. 980130

#### AS INTRODUCED

A congressional act amending the Undergraduate Student Congress Bylaws to create a process by which Ways and Means Committee Members shall recuse themselves in instances of conflict of interest, providing for a short title, providing for codification, and providing an effective date.

#### BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

- Section 1: Title: This act shall be known and may be cited as the "WAM Recusal Act of 2017"
- Section 2: Purpose: The purpose of this act shall be to create a uniform process by which members of the Ways and Means Committee of the Undergraduate Student Congress shall recuse themselves from funding decisions in order to increase transparency and accountability.
- **Section 3:** The Undergraduate Student Congress Bylaws are amended as follows:

#### Section 12.1 WAYS AND MEANS COMMITTEE OBLIGATIONS

- 1) Members of the Ways and Means committee shall inform the Committee Chair of any potential conflicts of interest in funding decisions including:
  - a. Membership in the Registered Student Organization that has requested funding
  - b. Having filled out the funding application being reviewed by the Committee
  - c. Having a close personal relationship with the person who filled out the funding application
- 2) The Chair shall determine whether the potential conflict of interest constitutes a legitimate conflict of interest.
- 3) If the Chair determines that it is a legitimate conflict of interest, the committee member shall not participate in the deliberations that determine said RSO's funding amount.
- 4) This rule shall exempt any funding request coming from any branch of the SGA
- 5) Should quorum, including the Vice Chair of Congress, be unable to be met due to the implementations of this rule, the requests shall be seen by the Ways and Means Committee and it shall be the responsibility of the Committee Chair to ensure a fair response to the request.
- **Section 4:** This act shall become effective when passed in accordance with the SGA Constitution.

allow for unilateral action to significantly reduce textbook prices, and

Whereas: Senator Dick Durbin has proposed the Affordable College Textbook Act, and

Whereas: Said act would act to ensure textbooks become more affordable for students, primarily

through the creation of a fund to purchase textbook rights, allowing for the digitization and

cheap sale of textbooks, and

Whereas: Said act would act through cooperation with textbook producers, rather than through

unilateral state action against them as opponents of the legislation might think, and

Whereas: Said act is designed to cease operation after a period of time if it is found not to be effective,

- Section 1: Title: This act shall be known and may be cited as the "Testing Materials Accessibility Act of 2017."
- Section 2: Purpose: The purpose of this act shall be to provide examination green books and Scantrons for the OU student body to use for any test they may have. These green books and Scantrons will be made available in the Student Government Association Office in the Conoco Student Leadership Center, the RA offices of Couch Center, Walker Tower, Adams Center, and Cate Center, and in the clubhouses of the Traditions East apartment complex. The cost breakdown is as follows:

1500 8.5"x11" Roaring Springs Green Books at \$0.45 per book 1500 7"x8.5" Roaring Springs Green Books at \$0.35 per book 3000 Scantron forms at \$0.30 per form 8.75% sales tax

#### Total: \$2,283.75

- Section 3: The Undergraduate Student Congress hereby authorizes the purchase and delivery of 3000 examination green books and 3000 Scantrons to be purchased, at a cost of \$2,283.75 to the Congressional Initiatives Fund, and distributed proportionally to each of the centers mentioned above.

#### **AS INTRODUCED**

A Concurrent Resolution regarding the recent Title IX rollbacks made by the federal government; and providing for distribution.

Whereas: Title IX of the Education Amendments of 1972 makes schools legally

responsible for responding to and remedying hostile educational environments;

and

Whereas: The former Title IX regulations strengthened protections for victims of sexual

assault on college campuses; and

Whereas: The Dear Colleague Letter in 2011 provided guidance to schools regarding how

to better handle sexual misconduct including but not limited to: 1) how to expand education for students on consent and sexual violence, 2) how to increase transparency regarding sexual assault policies and 3) how to investigate

instances of sexual violence in an equitable and fair manner; and

Whereas: The University of Oklahoma's faculty, staff, and student body have recently

implemented additional programs and initiatives to attempt to end sexual assault on campus, educate our community about the issue, and to provide increasing

support for survivors; and

Whereas: Recent actions taken by the Department of Education rollback these guidelines

and leave the requirements for schools ambiguous and weaken protections for

sexual assault victims; and

Whereas: The guidance provided by the Department of Education in September 2017

may be detrimental to victims of sexual assault from reporting sexual violence

by leaving the standard of evidence ambiguous; and

Whereas: Recent actions taken by the Department of Education go directly against the

mission and goals of the recent initiatives and programs the University of

Oklahoma has implemented; and

NOW, THEREFORE, BE IT RESOLVED BY THE UNDERGRADUATE STUDENT CONGRESS AND THE GRADUATE STUDENT SENATE THAT:

**Section 1:** This Concurrent Resolution shall be called "A Resolution Condemning Any and All Rollbacks of Title IX Protections for Victims of Sexual Violence."
