AS INTRODUCED

A congressional act streamlining Title V, providing for a short title, providing for codification, and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

- Section 1:** Title: This act shall be known and may be cited as the “The Title V Streamlining Act of 2017”
- Section 2:** Purpose: The purpose of this act shall be to clarify and correct ambiguities in Title V
- Section 3:** For the purpose of this legislation, all additions shall be marked with an underline and all deletions with a ~~striketrough~~.
- Section 4:** Title VI shall read as follows:

**Title V – The Programming Branch**

**Chapter 1 – The Campus Activities Council**

**1. The Campus Activities Council**

The programming branch of the SGA will consist of the Campus Activities Council.

**2. Duties**

The Campus Activities Council will be responsible for programming campus-wide activities for the SGA. The Campus Activities Council shall also be subject to duly passed legislative acts of the SGA.

**3. ~~Membership~~**

~~Any member of the SGA may be a member of any level of the programming branch.~~

**4. Chair**

The Campus Activities Council shall be headed by an elected Chair.

**a. Election of Chair**

The Campus Activities Council Chair shall be popularly elected by majority vote of the ballots cast in an election for that purpose. ~~The election for Chair shall coincide with the election for SGA President.~~ The Election of the Chair is subject to Title 7 and the Election Procedures Act.

**b. Term of Chair**

The term of office for the Campus Activities Council Chair shall begin in the spring semester one week after the validation of election.

**c. Impeachment of Chair**

The Legislative Branch has the power and authority to impeach and remove from office the Chair of the Campus Activities Council. No person charged with impeachment shall be convicted without the concurrence of two-thirds (2/3) of the Senate.

**5. Internal Proceedings**

The Campus Activities Council shall establish rules of procedure for the internal operations of the organization. These rules shall be published and available to students upon request.

**Section 5:** The SGA Staff Assistant shall be empowered to correct all clerical issues associated with re-numbering Title V based on the above changes.

**Section 6:** This act shall become effective on January 1, 2018 if passed in accordance with the SGA Constitution.

AS INTRODUCED

A congressional act repealing Title VI, providing for a short title, providing for codification, and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

- Section 1:** Title: This act shall be known and may be cited as the “The Title VI Repeal Act of 2017”
- Section 2:** Purpose: The purpose of this act shall be to abolish Title VI of the Code Annotated, insofar as Residential Governments do not fall within the direct oversight of SGA.
- Section 3:** REPEAL: The following sections of the Code Annotated marked with a ~~strike through~~ are hereby repealed:

~~**Title VI—Resident Governments**~~

~~**Chapter 1—General Provisions**~~

~~**1.—Membership**~~

~~The Residential Governments of the SGA shall be comprised as follows: Housing Center Student Association President; Commuter Student Association President; Interfraternity Council President; Panhellenic Association President; and National Pan-Hellenic Council President.~~

~~**2.—Residential Government Presidents**~~

~~The Residential Government Presidents of the SGA shall be as follows: Housing Center Student Association President; Commuter Student Association President; Interfraternity Council President; Panhellenic Association President; and National Pan-Hellenic Council President.~~

~~**3.—Residential Presidents**~~

~~The Residential Presidents of the SGA shall be as follows: Those presidents of organizations under the jurisdiction of the Residential Government Presidents, including Residence Hall Presidents in University Housing; and Presidents of fraternities and sororities.~~

~~**a.—Role**~~

~~Each Residential President shall be the chief executive officer of his/her defined center or organization.~~

**~~b. Terms~~**

~~The Housing Center Student Association President, Commuter Student Association President, and National Pan-Hellenic Council President shall be elected in the Spring SGA Election. The Interfraternity Council President, Panhellenic Association President, shall be elected in the Fall SGA Election. The term of office shall be January 1 to December 31 of the year following each Fall SGA Election.~~

**~~c. Other Employment~~**

~~No employee in a SGA stipend position shall be employed by the University of Oklahoma in a position that could be considered a conflict of interest. Neither shall he/she accept any special favors or privileges from any university employee or student or outside source which might in any way compromise his/her position and responsibilities while in office. This does not intend to include traditional and recognized academic and athletic compensation in the form of scholarships, fellowships, grants of other similar aid, or employment, which clearly does not represent a conflict of interest. Notification of other employment must be submitted to the office of the SGA General Counsel prior to elections for the purpose of determining a conflict of interest.~~

**~~d. Special Privileges~~**

~~Special privilege means a privilege, not conferred upon the regular student body, but conferred on center presidents solely because of their position. Special privileges are only prohibited when such privilege compromises, in any way, the office. To determine whether an impermissible special privilege has been granted, it must be determined whether the privilege was solely because of one's position and whether the privilege compromises the office.~~

**Title VI—Resident Governments**

**Chapter 2—Governments**

**~~4. Housing Center Student Association~~**

~~Membership in the Housing Center Student Association (HCSA) shall consists of all residents of the following residence halls: Adams Center, Cate Center, Couch/ Center, and Walker Center, Kraettli Apartment Complex, Traditions Square East Apartment Complex, and Traditions Square West Apartment Complex.~~

**~~a. Role~~**

~~HCSA shall strive to maintain a working relationship with the SGA. The Housing Center Student Association shall be a student organization and not a member of the Legislative, Judicial, Executive, or Programming Branch.~~

~~The purpose of the Housing Center Student Association is to enhance the living and learning environment of the university's residential community through programming, advocacy, and service.~~

**~~b. Resident Student Association~~**

~~Membership of HCSA shall be divided into Resident Student Association (RSAs) as determined by the center or apartment complex in which the student resides, in accordance to the HCSA Constitution.~~

**~~c. Housing Center Student Association General Council~~**

**~~i. Power~~**

~~The HCSA General Council shall have all legislative powers with respect to the Housing Student Center Association.~~

**~~ii. Membership~~**

~~The HCSA General Council shall consist of ten voting members from each RSA or as outlined in the HCSA Constitution.~~

**~~d. Housing Center Student Association President~~**

~~There shall be a Housing Center Student Association President~~

**~~i. Election~~**

~~The President shall be elected by a majority of residence hall, students voting in the Spring SGA General Election. If no candidate receives a majority in the general election a run-off will be held between the two candidates receiving the highest pluralities of votes cast in accordance with the SGA Election Procedures Act.~~

**~~ii. Term~~**

~~Should the President cease to be a regularly enrolled student at the University of Oklahoma for the Fall or Spring semesters, be impeached, or otherwise vacate the position, a replacement shall be named by a majority vote of all members of the HCSA General Council. If the President shall vacate the position or be aware of an impending vacant before the Fall SGA election, the position shall be filled at that time.~~

**~~iii. Removal~~**

~~The HCSA President shall be removed from office with a 2/3 majority vote of the HCSA General Council~~

**~~e. Housing Center Student Association Vice President of Internal Affairs~~**

~~The HCSA Vice President of Internal Affairs (VPIA) shall serve as the Chair of the HCSA General Council. The VPIA will assume the duties of the HCSA President if he/she is unable to do so.~~

**~~f. Impeachment~~**

~~Because neither the Housing Center Student Association nor its President is a member of the Legislative, Judicial, Programming, or Executive Branch, the Housing Student Association President is not subject to impeachment and removal proceedings of the SGA Legislative Branch.~~

**5. Interfraternity Council**

~~The Interfraternity Council shall consist of the students registered as either resident or nonresident members, associates or pledges, with active registered chapters or colonies of the Interfraternity Council.~~

**~~a. Logo~~**

~~Only the trademarked Intrafraternity Council logo shall be used in conjunction with the Intrafraternity Council. This trademarked logo shall replace the Greek Affairs IFC Logo.~~

**6. Panhellenic Association**

~~The Panhellenic Association shall consist of the students registered as either resident or nonresident members, associates, or new members with active registered chapters or colonies of the Panhellenic Council.~~

**7. National Pan-Hellenic Council**

~~The National Pan-Hellenic Council shall consist of the students registered as either resident or non-resident members with active registered chapters of the National Pan-Hellenic Council.~~

**8. Commuter Student Association**

~~The Commuter Student Association shall consists of all students not living in the previous sections of this chapter and excluding residents of active registered chapters of the Interfraternity and Panhellenic Councils.~~

**9. Latino Greek Council**

~~The Latino Greek Council shall consists of the students registered as either resident or nonresident members with active registered chapters of the Concilio Nacional De Hermandades Latinas.~~



**Section 4:** This act shall become effective on January 1, 2018 if passed in accordance with the SGA Constitution.

AS INTRODUCED

A congressional act setting pertaining to student appointments to the Board of Regents University of Oklahoma Presidential Search Committee, providing for committee creation, providing for application questions, providing for qualifications, providing for a short title, providing for codification, and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

- Section 1:** Title: This act shall be known and may be cited as the “Regents Student Selection Qualifications Act”
- Section 2:** Purpose: The purpose of this act shall be to create a committee for the purposes of judging applications for candidates to the Board of Regents University of Oklahoma Presidential Search Committee and to set formalized qualifications for candidates to the Board of Regents University of Oklahoma Presidential Search Committee.
- Section 3:** Definitions: For the purposes of this act, “Regents Search Committee” shall refer to the Board of Regents University of Oklahoma Presidential Search Committee, “Committee” shall refer to an internal committee of the Student Government Association as described in Section 4, Chapter 9, Sub-Section 49, and “Business Day” shall refer to an eight-hour period of time between 09:00 and 17:00 local time on a weekday that is not a university-sanctioned holiday.
- Section 4:** Amending Title XI – SGA Boards, Committees, and Commissions of the Code Annotated and establishing:

**Chapter 9 – Student Representation: Regents Search Committee**

47. Appointment/Confirmation/Nomination to the Regents Board for selecting the University of Oklahoma Presidential Search Committee shall be considered a High Office for all entering the board on or after February 1<sup>st</sup>, 2018. Any person appointed prior to this date shall be exempt from the concurrent service in high office.
- a. On or after February 1<sup>st</sup>, 2018, the SGA President, SGA Vice-President, and CAC Chair shall be exempt from the concurrent service in high office for the purposes of serving on the Regents Search Committee.
48. Applications must be open and made available to all students for a reasonable maximum amount of time based on time constraints provided by the Board of Regents.

- a. Should the time constraints provided by the Board of Regents exceed five (5) full business days, then the following shall apply:
    - i. A minimum of one (1) university-wide electronic mail (email) notification must be distributed to all students no fewer than five (5) full business days (excluding Saturdays, Sundays, and university-deemed holidays) prior to an internal application deadline set by the Student Government Association. The email shall notify students that applications for candidates for the Regents Search Committee are being accepted until the date and time of an internally-decided application deadline.
    - ii. Applications must be open at the time the initial university-wide electronic mail (email) notification is distributed.
    - iii. An additional university-wide electronic mail (email) notification must be sent between twenty-four (24) and forty-eight (48) hours prior to the internal application deadline.
    - iv. **Example:** An internal application deadline may be set at or after 17:00 local time on a Friday provided that the initial university-wide electronic mail (email) notification was distributed prior to 09:00 local time on a Monday and provided that Monday, Friday, and any day in between Monday and Friday are not university-sanctioned holidays.
    - v. Should time allow, the Committee, at its sole discretion, shall be both permitted and encouraged to extend the time for applications to better allow for an increased pool of applicants.
  - b. Should the time constraints provided by the Board of Regents not exceed five (5) full business days, then the following shall apply:
    - i. The Committee must make applications open and available to all students for a reasonable maximum amount of time.
    - ii. A minimum of one (1) university-wide electronic mail (email) notification must be sent out with as much advanced notice as possible. The email shall notify students that applications for candidates for the Regents Search Committee are being accepted until the date and time of an internally-decided application deadline.
    - iii. Applications must be open at the time the initial university-wide electronic mail (email) notification is distributed.
49. Applications shall be judged, with objective consideration of the applicant, their application questionnaire, and their interview, by a Committee consisting of the: SGA President, SGA Vice-President, Chair of the Undergraduate Congress, Vice-Chair of the Undergraduate Congress, Chair of the Graduate Student Senate, Vice-Chair of the Graduate Student Senate, and CAC Chair. Additional members may be added to the Committee with two-thirds ( $\frac{2}{3}$ ) consent of the Committee provided that the additional member(s) are not applying as a candidate for the Regents Search Committee.
- a. All active members of the Undergraduate Congress and Graduate Student Senate shall be notified by their respective Secretary, via writing or electronic writing and prior to the opening of applications, should an additional member be added to the Committee.

- b. The Executive Branch must notify the student body and the public, prior to the opening of applications and via a press release and/or similar means, of the members, including additional members, of the Committee.
    - i. The names of all members of the Committee shall also be disclosed on the university-wide email(s) distributed to the student body.
  - c. No member of the Committee shall be eligible for consideration as candidate for the Regents Search Committee with the exception of the: SGA President, SGA Vice-President, and CAC Chair.
    - i. Should the SGA President, SGA Vice-President, and/or CAC Chair be considered as candidates, they must be recused, though not dismissed, from the Committee.
      - 1. The SGA President may be un-recused only in the event of an evenly split (tie) decision in the Committee.
  - d. No additional members shall be added to the Committee once applications have opened.
  - e. A member of the Committee shall only be dismissed, and will be dismissed immediately, from their role on the Committee if they: resign from their elected seat, are removed from their elected seat, and/or meet the disqualifying standards of a candidate as described in Chapter 9, Sub-Section 53.
  - f. **Interviews**
    - i. All applicants shall be interviewed by the Committee.
    - ii. Interviews of applicants may occur on a rolling-basis in which interviews can occur once an application has been submitted.
    - iii. The Committee shall determine the method and manner of all interviews.
50. Following the internal application deadline, the Committee shall furnish a list of candidates and their application questionnaires to the Undergraduate Congress and the Graduate Student Senate. Each candidate shall be provided with a minimum of five (5) minutes, of which they are not required to use, in each legislative chamber for the purposes of presenting why they believe that they should represent the student body as the student representative on the Regents Search Committee. The candidates must individually be approved by a minimum of two-thirds majority via roll-call vote in both the Undergraduate Congress and the Graduate Student Senate.
- a. Under no circumstance shall there exist limitations on the amount of time for questions to the candidates.
  - b. Members of the student body shall be given full speaking privileges, without threat of objection, to ask questions to the candidates.
    - i. This shall not imply any change to preexisting voting regulations.
  - c. The Executive Branch shall notify the student body, via press release and/or similar means, that candidates will be seen in both the Undergraduate Congress and the Graduate Student Senate.
    - i. Such a notification shall state the dates, times, and locations when/where candidates will be presenting.
    - ii. Such a notification shall also state that the student body will be granted full speaking privileges for the purpose of asking questions to the candidates.
51. **Application Questionnaire:** The application shall be conducted via OrgSync (or the future successor of OrgSync should OrgSync no longer be used by the university). The application shall

include a list of: minimum qualifications, directions, a purpose, questions, a signature, and a signed date. Additional questions, either qualification or written-answer, may be asked provided that the following questions are asked; below are the questions that must be asked:

- 1: Do you plan to still be enrolled in classes as a student at the University of Oklahoma by the end of the date specified for the Regents Search Committee? **YES NO**
- 2: Will you be able to attend the interviews by the executive branch on said date(s) on campus if granted an interview and the appointment/confirmation/nomination meeting(s) from the Undergraduate Student Congress & Graduate Student Senate? **YES NO**
- 3: Being on a search committee takes a large amount of time. Are you prepared to invest the time and commitment, while doing due diligence of research and not missing a single meeting so the Student Vote & Voice counts? **YES NO**

**52. Qualifications:** For undergraduates to serve as the student representative on the Regents Search Committee, they must have a minimum of a 2.5 overall GPA at the time of their appointment, have completed 40 or more credit hours, and have been a student at the University of Oklahoma, Norman for a minimum of two full semesters at time of appointment (Fall/Spring/Summer).

- a. **Graduate Students:** For Graduate Students, they must be in good standing with their College of Study.
- b. **Law Students:** For Law Students, they must be in good standing with the University of Oklahoma College of Law and the Student Bar Association.
- c. **Sooners Studying Abroad:** Students studying abroad during any time of the application process and/or at any time the Regents Search Committee is expected to convene shall be ineligible for consideration to the Committee.

**53. Disqualifications:** Any student wishing to serve as the student representative on the Regents Search Committee shall be deemed ineligible by the Committee if they have been found guilty of any: academic misconduct OR sexual misconduct OR bribery violations/laws OR criminal felonies as tried in a public court of law.

**Section 5:** This act shall become effective immediately upon passage and shall be codified in the Code Annotated.
