AS INTRODUCED

An act of procedure acknowledging the Fall 2017 student holiday; providing for codification; providing for a short title; and providing for an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION

- Section 1:** This act shall be known and may be cited as the “OU-Texas Holiday Act of 2017”.
- Section 2:** This holiday helps the student body to travel and prepare for the celebration of defeating the University of Texas football team in Dallas.
