AS INTRODUCED

An Act submitting the Fall 2020 unscheduled holiday;
providing for a short title; providing for legislative intent;
and providing for an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: TITLE: This act shall be known and may be cited as the “Red River Holiday Act of 2020.”

Section 2: PURPOSE: The purpose of this act is to officially submit an Unscheduled Holiday to the University President for Approval per the University of Oklahoma Regents’ Policy Manual Section 5.15.

Section 3: The University of Oklahoma Student Government Association officially submits Friday, October 10th, 2020 as the Fall 2020 Student Holiday.

Section 4: In accordance with the SGA Code Annotated and Constitution, this Act shall become effective immediately upon passage and approval.
