## CONGRESSIONAL BILL CB-105-03

#### AS INTRODUCED

A Congressional Act of Legislation to update the name of the "Election Board" and "Election Chair" in our Congressional Bylaws; providing a short title; and an effective date.

# BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION UNDERGRADUATE STUDENT CONGRESS:

Section 1: Title: This act shall be known and may be cited as the "Mission: Election Commission."

- Section 2: Purpose: The University of Oklahoma's Student Government Association passed the "True Democracy NOW Act of 2020" changing the name of the "Election Board" to "Election Commission" and "Election Chair" to "Election Commissioner." Therefore, the terminology in the Congress Bylaws must be updated to reflect this change.
- Section 3: AMENDATORY: Update all terms and uses of "Election Board" to "Election Commission," and "Election Chair" to "Election Commissioner" in the Undergraduate Student Congress Bylaws.
- Section 4: Pursuant to the University of Oklahoma Student Government Association's Undergraduate Student Congress Bylaws § 2.3.4, the Congress Vice Chair should update the terminology and add or remove any language needed to keep the grammatical integrity of the sections containing "Election Board" and "Election Chair" intact.

Section 5: This act shall become effective when passed in accordance with the SGA Constitution.
