Section 1:

## AS INTRODUCED

An Act submitting the Fall 2021 Unscheduled Holiday; providing for short title, providing for legislative intent, and providing for an effective date.

Title: This act shall be known and may be cited as the "Red River Holiday Act of 2021."

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

CONGRESSIONAL BILL AB-106-01 SENATE BILL NO. GF21-XX

#### **AS INTRODUCED**

An act relating to appropriations; providing for short title; stating purpose; appropriating Auxiliary Funding for the 2021-2022 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

# BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: This act shall be known and may be cited as the "Auxiliary Allocation 1 Act of 2021-2022"

**Section 2:** PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.
