CONGRESSIONAL BILL AB-108-02  
SENATE BILL NO. GF22-XX

AS INTRODUCED

An act relating to appropriations; providing for short title; stating purpose; appropriating Auxiliary Funding for the 2022-2023 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

**Section 1:** This act shall be known and may be cited as the “Auxiliary Allocation 2 Act of 2022-2023”

**Section 2:** PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.

**Section 3:** APPROPRIATION. The following amounts are hereby allocated to

**Section 5:** This fiscal year for the account listed in these sections shall end May 6, 2023

**Section 6:** All unspent money remaining in the accounts listed in Section 3 shall revert to the SGA General Account after May 6, 2023, and the remaining appropriations shall be canceled.

**Section 7:** This act shall become effective when passed in accordance with the SGA Constitution.
