CONGRESSIONAL BILL CB-108-13 SENATE BILL GSXX-XX/GFXX-XX

AS INTRODUCED

An Act appointing the Fall 2022-Spring 2023 Election Commission Staff; providing for short title, providing for codification, and providing for an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

- Section 1: Title: This act shall be known and may be cited as the "2022-2023 SGA Election Commission Staff Appointment Act."
- **Section 2**: Purpose: The purpose of this act shall be to appoint the members of the 2022-2023 Election Commission Staff.
- **Section 3**: In accordance with Title IV, Chapter 6, Section 2(a)(ii), The Election Commissioner shall appoint the Election Commission Staff with the advice and consent of the Legislative Branch. The following SGA Members shall be appointed as Election Commission Staff for the term ending at the end of the Spring 2022 Semester:

 - Laura Hoehner

Section 4: This act shall become effective when passed in accordance with the SGA Constitution.
