CONGRESSIONAL BILL CB-111-11 SENATE BILL GS24-XX

AS INTRODUCED

An Act of Legislation establishing a referendum to amend the University of Oklahoma Student Government Association Constitution to remove all references to the University College District; providing for short title; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

- **Section 1**: Title: This act shall be known and may be cited as the "UCOL Regulation Removal Amendment."
- **Section 2**: Purpose: The purpose of this act shall be to remove all references to the University College District from the SGA Constitution to align with university restructuring plans.
- **Section 3**: AMENDATORY: The Student Government Association Constitution Article III, Section 2.1 is amended as follows:

Representatives of Congress shall be elected on the basis of their academic district. Students will be classified by their most recent declared major except in the case that said student is in the University College as determined by official University records. Vacancies in elected districts shall occur when a representative changes districts; however, representatives of the University College District shall serve for their full term, even upon moving to their declared major's college.
