# AS INTRODUCED

### **AS INTRODUCED**

An act relating to appropriations; providing for short title; stating purpose; appropriating Auxiliary Funding for the 2021-2022 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

# BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: This act shall be known and may be cited as the "Auxiliary Allocation 9 Act of 2021-2022"
