Cassidy: I would love to talk in caucus. This bill was written based off a year of discussion. The bill was vetoed because of the transparency requirement. Someone went to the committee on my behalf. I believe that all the issues would all have been fixed if we had these requirements. Some of the requirements in this bill would be having a 24-hour notice of the meeting and agenda. This would also require agenda and minutes to be public. Basically, this would keep them from not having secret meetings. We care about transparency, if someone wants a raise, you would want to know why they get what they get, and wouldn't you want to know when your grievance was being talked about. Wouldn't you want to know everything they are talking about? This is the most minimal requirement we could ask of an organization if they are holding meetings. Gibbs: We need transparency. But we do have SGA representation. I want to keep all the language in this bill the same. We still have

CR-102-08 A Resolution Supporting the Implementation of the STEV platform (Bonić)

Bonić: I will introduce two people to give an explanation of their program. They have a presentation and would appreciate an extension of their authors explanation.

Motion to extend Authors' explanation by 15 minutes Representative Werdel seconded by Representative Rojas

Jett: We developed a website called STEVE. I am a mechanical engineering major and he is too. We wanted to change the way the existing course evaluations are available to students. They are public but hardly accessible. They are posted in collections of PDF files. They are very hard to find even though it is very important to be able to look at other instructors' reviews. University of Idaho has one of these but also has student reviews publicized. University of Oklahoma does not have this. Right now, on the OU website, each semester has a link and it will take you to a large PDF file and you can sort through all of them on your own, but these are not helpful at all. We wanted to take the date and put the data in, in a more friendly way. Students typically use Rate My Professor, but these reviews are skewed. There are questionable comparative measures. A problem with this website is the adds. For example, this is a professor that has been here for years but there were only four reviews. Schuermann: We are trying to create a bridge between students and this information. This is a more reliable source than Rate My Professor. With STEVE, students can easily look up professors and this will bring the data to the public.

Jett: We worked with admin office and some of the colleges. This is the website that we built. We will look up Dr. Hayes. If you are trying to see if a course was offered in one semester it will probably offered in another semester. You can also tailor things that you are interested in a more uniform way. You can look at individual questions and see how they compare to other courses. You can sort by course as well. You can also see all the professors that taught this course. This is the most recent semester. We encourage you all to look at this. You can see how this course did relative to the department average. Our goal is to publish this app, we want more data and to make it more applicable. We want to apply faculty feedback. We have talked to a couple people involved to get their feedback. We want this up and running by spring 2020.

Schuermann: We have developed the entire application, but we are graduating so we want to give this to the university so that other students can carry this on. If anyone has anything, they want to add to the application they could add their own code. This could also turn into capstone projects. We have spoken to faculty and students and gathered feedback, now we want SGA to serve as a proxy between us and administration. We would like to see some validation.

Bonić: We want to support this application to show administration that SGA supports this application. I did a lot of research and a lot of reviews are really bias. A lot of you didn't know that the course evaluations are pubic. This is a great way of putting things in a concise way. If anyone has any questions, please ask.

Rojas: In a lot of departments, there is one professor per class, in Rate My Professor there is a review from one student but sometimes the professors can ask to take things down, if this gets implemented can the professor ask to remove reviews?

Jett: No, they should be publicly available, and they are state employees. In the current system, a professor can opt out of putting their reviews publicly. 95% opt in to posting them. There needs to be some action taken is this aspect, however. The committee that we spoke to said they were on stage one of four and we were disappointed in that. Students can also have biases, but they need to be able to use this as a tool.

Schuermann: They cannot retract anything previously published. They cannot be removed or altered retroactively. Sam was saying that professor can decide to make new ones public but most of them to not.

Bouch: What is your timeline for this project?

Jett: The website is functional, right now we are waiting on administration. We are hoping that SGA's support would help with that process.

Schuermann: New issues will come up software wise. We are looking to be phased out and trying to get more people on.

Bouch: Are there going to be transition documents for the new people getting involved in this? Jett: Yes.

Schuermann: The source code is also public.

Jett: So are the bugs.

Nadolski: How do you see this resource fitting in with what SGA has already set in place regarding the updates course evaluation questions?

Bonić: I told them about University Policy's project, that we are trying to make them less bias. They are perfectly able to change based off of the questions that are asked they can change the data.

Rojas: Does this have to go through each college individually?

Bonić: They need support individual support from each college.

Bonić: They want support to be able to talk to department heads.

Jett: There is a faculty committee which has been tasked with the evaluation process and a lot of times they believe they are being graded unfairly. They want better questions. If the instructor is teaching the same class for a long time and getting continuously negative feedback and nothing is changing, that is a problem. But if it is not being enforced then nothing can be done.

Schuermann: We have developed this entire application independent from the entire university. The PDF that you saw came from OU internal database. We made contact with the University to help us streamline the data straight from a couple different colleges. We will want to do this for all the departments. If that doesn't work, we have created systems to do that on our own.

Werdel: Will this cost the university?

lett: No.

Schuermann: The app has to run on server infrastructure. Cost is incredibly minimal.

Nadolski: Are the creators of the website aware that the body is really impressed by this?

Schuermann: Thank you!

Ahmadi: Is this a congruent resolution or a congressional one?

<u>CR-102-07 A Resolution to Establish an OU Collegiate Recovery Program. (Gibbs/Patterson)</u>

Gibbs: Over the last semester I have talked to student affairs about student recovery program.

Huckabee: I am someone in long term recovery from drugs and alcohol. 3 years ago, from Texas Tech. That program offered me a scholarship to go to college. Without this I would not be in college. This changed my life and my family life. There are about 102 students in this program. I went to DC for a national conference where there were thousands of people in this program and over 140 universities that have this program. There is a governing body that sets standards. In June I have been doing my best to educate the University on these programs. Established organization students in recovery. This provides a safe space for students in recovery. This provides students who are struggling with addiction have a safe space.

Cordova: Is this a program that is already at this school? How many people would benefit?

Huckabee: Lots of students would benefit. Currently there are 452 students seeking recovery. We have an intervention program here. But we do not have anything that sustains or supports long term recovery. We can intervene. University of Alabama wanted to add to the intervention.

Bouch: What is your implementation plan here on campus?

Huckabee: It is going to be different than other places. The plan is to work with health services and student affairs. If a student gets referred to intervention, a strike 3 would remove them from the university. 10 students had to withdraw to get treatment because they cannot focus on education.

Merchant: Ideally, what does this program look like?

Huckabee: There would be a director and a student assistant. Hopefully 12 separate recovery meeting spaces. They would be looking at transfer students and new students as well as reaching out to the community. There are statistics show that students in these programs have higher GPA's and retention rates across the board.

- · Associates of General Counsel: \$11.00 x 25 hours/week x 34 weeks
- · General Counsel: \$12.00 x 25 hours/ week x 48 weeks
- · Chief of Staff: \$10.00 x 10 hours/week

The Chief of Staff shall be appointed by the SGA President following an open application process.

- · Election Board Members: 5 per election, \$40x5 persons x 2 general elections
- · Election Chair: \$350/Spring General Election, \$350/Fall General Election
- · Election Poll Operators: 20 Individuals per election, \$20x20x 2 elections

Election Board Members, Chair, and Poll Operators are appointed according to the Elections Procedures Act.

- · SGA and RSO Staff Assistant-II: \$16.40/hour x 2080 Hours
- · SGA and RSO Budget and Account Representative-II: \$17.66/hour x 2080 Hours

The above positions are selected based upon applications received through the HR website, jobs.ou.edu. Selections are made by the SGA President, SGA Vice President, Congress Chair, Senate Chair, and CAC Chair, as well as their staff supervisor in Student Affairs. Increases in pay are given at the discretion of the aforementioned officials. Additionally, if university wide raises are mandated, the above positions shall receive those increases.

- · Student Organization Resource Officers: \$10.00 x 10 hours/week per officers
- · SGA Graphic Designer/Webmaster: \$10 x 10hours/ week x 34 weeks

The above positions are selected based upon applications received through the HR website, jobs.ou.edu. Selections are made by the SGA President, SGA Vice President, Congress Chair, Senate Chair, and CAC Chair.

• OU Student Legal Services Staff Attorney: \$40,000 per year.

The OU Student Legal Services Staff Attorney shall be hired by the Vice President of Student Affairs.

Any position not enumerated above shall not receive a salary/stipend.

A Congressional Act amending the Undergraduate Student Congress Bylaws; providing short title; providing for codification; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION UNDERGRADUATE STUDENT CONGRESS:

- **Section 1:** Title: This act shall be known and may be cited as the "Problems and Projects Committee Reform Act of 2019"
- Section 2: Purpose: The purpose of this act shall be to amend the name, committee purpose, and committee chair role of the Problems and Projects Committee in order to ensure a more comprehensive committee that can adequately address student concerns.
- **Section 3:** AMENDATORY: Section 7.1.4 of the Undergraduate Student Congress Bylaws is amended as follows:
 - 4. PROBLEMS AND PROJECTS CAMPUS SAFETY AND CONCERNS

- **Section 4:** AMENDATORY: Section 7.1.4a of the Undergraduate Student Congress Bylaws is amended as follows:
 - a. COMMITTEE PURPOSE The Problems and Projects Campus Safety and Concerns Committee shall use the Student Congress's resources to resolve all problems concerns regarding university infrastructure, student experience, and all other student problems concerns that the Student Congress this committee can reasonably respond to.
- **Section 5:** AMENDATORY: Section 7.1.4b of the Undergraduate Student Congress Bylaws is amended as follows:
 - b. COMMITTEE CHAIR The Committee Chair shall be charged with maintaining and following up with the Undergraduate Student Congress electronic suggestion box. The Committee Chair shall coordinate with the Congress Chair to refer suggestion box submissions to other committees, should they appropriately fall under another committee's responsibilities. The Committee Chair shall work with the Directors of the Department of Inclusivity and Interior in the executive branch to address campus safety and all other student concerns that fall within the committee's purview and mandate.
- **Section 6:** This act shall become effective when passed in accordance with the SGA Constitution.

- **Section 4:** AMENDATORY: Article IV, Chapter 2, Section 7 of the SGA Code annotated is amended as follows:

7. Membership

The judges of the Student Superior Court shall be regularly enrolled students and must have completed <u>either</u> two (2) semesters as a full time student at the University of Oklahoma <u>or</u> <u>be at least a 1L at the University of Oklahoma College of Law</u> at the time of this appointment and confirmation.

Section 5: AMENDATORY: Article IV, Chapter 2, Section 11 of the SGA Code annotated is amended as follows:

11. Membership

The judges of the Student Superior Court shall be regularly enrolled students and must have completed <u>either</u> two (2) semesters as a full time student at the University of Oklahoma <u>or</u> <u>be at least a 1L at the University of Oklahoma College of Law</u> at the time of this appointment and confirmation.

Section 6: AMENDATORY: The SGA Constitution enclosed herein is amended as indicated.

Section 7:	The constitutional amendment shall become effective immediately upon passage by the University of Oklahoma Board of Regents, while in compliance with Regents policy and the Constitution of the Student Government Association
