Secretary's Report – Welcome back everyone! I hope you guys had a good week. Just one thing to go over today. If anyone wants to make any friendly amendments, you have to come up here and grab a friendly amendment sheet and fill it out and turn it into me as soon as its accepted. If you are interested in running for Secretary, please let me know!

Committee Reports-

- O Campus Outreach, Safety, and Concerns: We didn't meet this Sunday, everyone was sick. We did talk, however about planning on meeting with Dr. Surrat about cooperation between SGA and student life center. We also have a parking appeals meeting. We are also booting up projects from last year.
- O Congressional Administration: We had a long conversation about election reform. More to come on that. In the meantime, Hillis is going to present a piece of legislation regarding parking appeals board. Fixing "court" wording. We will be holding Interviews on Saturday from 12-5pm. Applications close this Thursday at 11:59pm. We added a Friendly Amendment to the Associate Defense Legislation and gave it a recommendation of do pass. The friendly changed the wording to "any associate". Rather than take out the section of the bylaws, it now would apply to specific associates. We tabled 2 appointments, executive branch asked us to. These included the Executive assistant and the legislative assistant decision. We gave all of them a recommendation of no

- recommendation. We gave a recommendation of do pass to the liaison bill, and a recommendation of do pass to committee changes.
- External Affairs: We talked about Higher-Ed day. The date is set for February 11th. We made a spreadsheet with times to see senators, for people who want to go.
- o **Human Diversity:** Next Monday Feb. 3_{rd}, we will be pairing with the student democrats for a last-minute voter registration drive. We will be in the Union from 10am-2pm.
- O Sustainability: We planned for meeting Monday for 2 people in housing and food to discuss reusable containers. We will be presenting our results from the survey to them. We received 400 survey results which was pretty good. We will be contacting Big Event and CAC to see if they are following through with things we talked about last year. Planning on doing healthy eating but tabling was not super effective, so we were thinking about a social media campaign, we just don't know how that would look. We also have a Trash walk scheduled February 16th.
- O University Policy: We have appointed a new vice chair. Crispin. I have another meeting at 6:30 so he's going to be me when the meetings last long. We followed up on a mental health project from last semester. It was shot down by OU lawyers as a liability. We do have 2 different parking project ideas. Looking into regarding every type of parking pass being able to park at any spot over Christmas break or spring intersession. And then another one regarding the tags when you have to hang, getting rid of those making them more environmentally safe. We have another project regarding communication on the university.

AS INTRODUCED

An act relating to appropriations; providing for short title; stating purpose; appropriating Auxiliary Funding for the 2019-2020 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: This act shall be known and may be cited as the "Auxiliary Allocation 13 Act of 2019-2020"

Section 2: PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.

CONGRESSIONAL BILL CB-103-12

AS INTRODUCED

A Congressional Act of Procedure amending the Undergraduate Student Congress Bylaws; providing short title; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION UNDERGRADUATE STUDENT CONGRESS:

- **Section 1**: Title: This act shall be known and may be cited as the "Associate Membership Defense Act."
- **Section 2**: Purpose: The purpose of this act is to amend the Bylaws of the Undergraduate Student Congress to ensure that Associates maintain their full appointed membership status.
- Section 3: AMENDATORY: Section 3.3 of the Undergraduate Student Congress Bylaws is amended as follows. For the purposes of this bill, all items removed shall be denoted with a strikethrough. All items added shall be denoted with an underline.
 - 5. Motion to Suspend the Membership Privileges of any Associates
 - a. A motion to suspend the membership privileges of <u>any</u> Associates shall temporarily suspend all membership privileges of associates, including but not limited to motion making, voting on procedural questions, and automatic recognition to speak.
 - b. A motion to suspend the membership privileges of any associates shall take precedence over all other legislation, motions, business, speeches, or activity of Student Congress. This motion may be made at any time.
 - c. The motion requires a second and shall pass upon a majority vote of all Representatives present and voting at a given general body meeting or committee meeting. Associates may not vote on the question during a committee meeting.
 - d. Suspension may not be limited to a subset of associates smaller than the complete set of associates. Suspension may not be limited to a subset of privileges lesser than the complete set of membership privileges.
 - e. Suspended membership privileges of associates shall be restored upon a majority vote of representatives present and voting at a general meeting or committee meeting.
 - f. Unless a time is otherwise specified by the motion to suspend the membership privileges of associates or said privileges are restored by a later motion, said privileges shall be restored at the completion of the general meeting or committee meeting in which said motion to suspend the membership privileges of associates was made.

- **Section 4:** All further subdivisions of Section 3.3 of the Undergraduate Student Congress Bylaws shall be re-numbered to reflect the removal of Section 3.3.5.
- **Section 5:** AMENDATORY: Section 4.2.5 of the Undergraduate Student Congress Bylaws is amended as follows:

d. GENERAL MEETINGS

- i. As members, duly appointed associates have automatic speaking privileges, except as temporarily suspended.
- ii. No associate may vote in a general meeting except during Committee of the Whole. No associate may make any motion in a general meeting except during Committee of the Whole. No associates may object to motions in general meetings except during Committee of the Whole
- iii. All associates, unless they have a previously mentioned longstanding time conflict, will be required to attend one general meeting every month.

e. COMMITTEE OF THE WHOLE

- iv. Associates have automatic speaking privileges during Committee of the Whole, except as temporarily suspended.
- v. Associates may vote on all questions in Committee of the Whole, except as voting privileges are temporarily suspended. The request of any one representative with the second of another shall temporarily suspend voting privileges of associates for a vote on a recommendation of "Do Fail."

f. COMMITTEE MEETINGS

- vi. Associates have automatic speaking privileges at committee meetings, except as temporarily suspended.
- vii. Associates may vote on all questions in committee except as voting privileges are temporarily suspended.
- viii. Associates may make any motion otherwise in order in committee

Section 6: AMENDATORY: Section 4.3.2.a of the Undergraduate Student Congress Bylaws is amended as follows:

Representatives, Officers, and Associates and officers of the Congress have speaking privileges at all committee meetings. Associates have speaking privileges except as temporarily suspended. All individuals recognized for presentations in Special Orders, authors of past legislation during follow-up reports, and authors of currently moved legislation during author's explanation, questions to the author, and author's summation have speaking privileges at the respective times. All other individuals present may be granted speaking privileges at a committee meeting with the consent of a majority of members present and voting.

Section 7: This act shall become effective when passed in accordance with the SGA Constitution.

CONGRESSIONAL BILL CB-103-14

AS INTRODUCED

A Congressional Act of Procedure amending the Undergraduate Student Congress Bylaws; providing short title; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION UNDERGRADUATE STUDENT CONGRESS:

- **Section 1**: Title: This act shall be known and may be cited as the "Liaison Requirement Removal Act."
- Section 2: Purpose: The purpose of this act shall be to amend the Bylaws of the Undergraduate Student Congress to remove all mentions of a liaison requirement in order to reflect new standards for congressional service.
- **Section 3**: AMENDATORY: Section 4.4 of the Undergraduate Student Congress Bylaws is amended as follows. For the purposes of this bill, all items removed shall be denoted with a strikethrough. All items added shall be denoted with an underline.
 - 1. All members of the Student Congress are required to be a liaison. Newly elected or appointed members need not meet the liaison requirements listed below during their first month of membership.
 - 2. At the discretion of the Vice Chair, any member of the Student Congress may be appointed to serve as a Liaison of Student Congress to any organization on campus or within the Norman community. The Vice Chair shall maintain a list of aforementioned organizations that have requested and are eligible to receive a liaison.
 - 3. Liaisons shall be appointed only after the approval of both the Vice Chair of Congress and the highest authority of the entity that a liaison is being appointed to.
 - 4. Representatives must serve as a liaison to an organization within the Academic District they have been elected or appointed to represent. At the discretion of the Vice Chair of Congress and the highest authority in the desired student organization, Representatives may be the liaison to an organization that serves a large portion of the student body.
 - 5. Associates shall serve as at-large liaisons. The Vice Chair of Congress must assign them to an available organization.
 - 6. Should an organization specifically request a member of Congress to be their liaison, the member may be assigned to that group upon the approval of the Vice Chair.
 - 7. Liaison Requirements include:
 - a. STUDENT ORGANIZATION MEETING ATTENDANCE: Liaisons must attend one (1) meeting of their assigned organization each month that Congress holds a general meeting. This requirement must be met by attending the organization's general meeting, an executive committee meeting, or a personal meeting with an executive officer.

- b. STUDENT ORGANIZATION EVENT ATTENDANCE: Liaisons must attend one (1) event hosted by their assigned organization by 1 week before the end of each Congressional Session.
- c. At the discretion of the Congress Vice Chair, liaisons unable to complete a requirement(s) are eligible to participate in an alternate form of service to fulfill said requirement(s).
- d. Each Liaison Requirement must be submitted via OrgSync. The Congress Vice Chair will then either approve or deny the form if the requirement is met.
- 8. On the Sunday of the last week of the month, the Vice Chair will notify all liaisons who have not completed the Student Organization Meeting Attendance Requirement. Two weeks before the end of each Congressional Session, the Vice Chair will notify all liaisons who have not completed the Student Organization Event Attendance Requirement.
- 9. Members shall accrue an absence for failure to meet a Liaison Requirement or for failure to submit proper documentation by the dates detailed in Section 4.4(6)(a) and Section 4.4(6)(b). a. The Ways and Means Committee Chair shall not accrue an absence for failure to meet the requirements outlined in Section 7.
- **Section 4:** All further subdivisions of Section 4 of the Undergraduate Student Congress Bylaws shall be re-numbered to reflect the removal of Section 4.4
- **Section 5:** AMENDATORY: Section 5.2.9 of the Undergraduate Student Congress Bylaws is amended as follows:
 - 9. The Vice Chair will be responsible for the maintenance and execution of the Liaison Program and shall maintain a list of prominent organizations that are available to receive a liaison.

 - 3. This report is not required if the above necessity does not exist.
