CR-102-11 A Resolution Condemning Blackface on Campus (Bouch/Miller)

Bouch: I'm Malachi, I am the Congressional Administration chair, Miller and I wrote this resolution. We want to make a point for the entirety of the Student Government Association to finally say something about the repeat incidents and how blatantly racists these blackface incidents are. Congress has neglected to say something for the past 2 incidents. President Gibbs has made statements, but it wasn't all of us in the student government who wrote one cohesive statement.

Miller: As representatives, we are wanting to echo was executive branch said.

Stack: Aside from telling everyone that we condemn it, what will this resolution do?

Miller: This is our way of saying that we understand its wrong and we are an ally. It shows these communities that they can come to us and we can sympathize.

Bouch: We haven't paid enough attention to the gapping whole that we can urge the University to fill. This bill will move congress's focus on these things.

Stack: So, to clarify, this takes no real action?

Miller: Correct.

Chism: There is lots of history with these actions, so I am just confused as to why the resolution is so brief? Bouch: We've got a few friendly amendments coming in adding 2 whereas clauses, not for the purpose of making it longer but to emphasize some things we didn't touch. We are writing this as a preamble to let legislation that will have action follow, is not a solution but legislation could follow that comes out of this body.

Miller: We are all working on projects that could help the community, but they take a long time to finalize. Mayes: Would you accept a friendly Amendment adding the Whereas Clause stating that the University of Oklahoma Student Government Association has been derelict in its duty by not addressing this issue in the past. After the 2nd clause.

Bouch: Yes.

Thompson: Would you accept a friendly amendment changing we are the largest student organization to one of the largest?

Bouch: Yes.

Tucker: Would you accept a friendly amendment in section 2 striking "community and pledge that..." changing the language the language to "...community. Let them also be informed that we pledge ..." Bouch: Yes.

Chism: In the 3rd section mentioning the undergraduate congress, are you open to a Friendly Amendment adjusting the wording to something else?

Bouch: Yes but it started here in congress but I would be opened to change the wording to SGA. Chism: Would you accept a Friendly Amendment replacing "congress" with "student government association?"

Bouch: Yes.

Chism: Would you accept a Friendly Amendment adjusting the spelling of "Black" when it occurs with a capital B?

Bouch: Yes.

Thompson: Would you accept a friendly amendment adding whereas clause "The Undergraduate Student Congress is committed to educating ourselves and peers about the history and effect of racism on our campus?"

A while ago, I took a stance on EPA a while ago that was a minority in the opinions of the body. I voted against the bill because it was not in the interest of my college.

Gibbs: I will make sure that she gets in contact with Sam Quick. I will fill both Emily in and Sam. Merchant: If you are appointed, what are you most looking forward to?

Smith: I am excited to work with Student Legal Services because students' rights and law should be more accessible. College student rights are an abstract concept.

Patterson: Could you explain a little, for those in the body who don't know, what General Counsel is? Gibbs: General Counsel helps students if they have grade appeals and honor code violation, we advise them, Smith: I am kind of a resource for anyone in SGA for what the code says or what the proper course of actions is. I also deal with opinions on how things should work.

Smith: I've been told it is located on the 2nd floor of the Conoco.

- Whereas: The Student Government Association is the one of the largest Student Organizations on Campus, and we serve as a role model to OU students as a whole.

Whereas: The Undergraduate Student Congress is committed to educating ourselves and peers about the history and effect of racism on our campus

## BE IT RESOLVED BY THE UNIVERSITY OF OKLAHOMA UNDERGRADUATE STUDENT CONGRESS AND THE GRADUATE STUDENT SENATE, CONCURRING THEREIN THAT:
