AB-103-01 Auxiliary Allocation 11 Act of 2019-2020 (Patton) (Executive Committee> Rec of Do Pass) Patton: Hello! Sorry my computer is on the brink of death. Our committee met unofficially last week so they saw organizations too. The executive committee saw the bill before you guys. We saw 11 organizations and allocated about \$4,000.

Representative Chism seconded by Representative Carmona

CR-102-11 Resolution for Diversity, Equity, and Inclusion within the Student Government Association (DeAngeli/Miller) (Executive Committee> Rec of Do Pass).

DeAngeli: This was what was formally the blackface bill that the Graduate Student Senate failed because members of the black community were not in favor of the bill. It was not kosher to pass it in congress. GSS moved this resolution to joint committee.

Miller: In the resolution, we have listed a few ways that the committees within the Student Government Association could make their processes more inclusive!

Chism: Just to clear things up on why we basically did a 360 with this resolution and decided to focus on diversity not the blackface incident, black members of the body did not vote for this. We do not need to pass a resolution condemning blackface because no one really is waiting for congress's disapproval. We decided we were going to discuss what we are going to do to mitigate future incidences. We aren't just going to just say racist things are bad.

Spangler-Day: We set some concrete goals that we wanted to check off the list. We don't want to remain stagnate.

DeAngeli: This was created with the GSS chair and vice chair and the GSS vice chair of the human diversity committee. I tell you that to clarify that the things that we are mandating were approved by everyone.

Chism: We wanted to write something to do for every committee, partly to show that your committee can actually do something. I am really excited about this.

Miller: This will also be able to hold us all accountable for next semester.

Marvin: You all said there was something to do with every committee, because I do not see my committee? DeAngeli: Campus Outreach Safety and Concern is under section bullet under section 2.

Hillis: Under Human Diversity committee, what "continue activities," mean?

Miller: We have had the implicit bias tabling in the past and I believe that HD is doing a good job turning out events for marginalized groups. We've also had a poetry and prose night during rape awareness week, a forum for immigration, and an International Friendsgiving. We will also have more affordable housing for students coming soon in January.

Marvin: In the second whereas, the only source is collegefactual.com. Where did this 3rd party website get their stats? Is there a better source? Are these real OU demographics?

DeAngeli: I put the link in. Sorry it was just the link and not the properly formatted source.

Collegefactual.com takes the diversity reports from the University. The rest of the statistics were incredibly hard to dig through. This was a more comprehensive visual than real data points. The data was from OU.

CR-103-01 A Resolution Increasing Halal, Vegan, and Gluten-Free Signage in Campus Dining Areas. (Garg/Miller) (Executive Committee> Rec of Do Pass)

Miller: This is a resolution solving a student concern that addressed a lack of availably of Halal and other dining restricted foods. There are actually these options available. When we met with an administrator, we were given three full menus and they were not being advertised. We settled on stickers on the overhead menus. The menus we were given are not up to date. This will give them an opportunity to increase options. This will give Housing and Food and opportunity to update them. We already have the options and they are already available. The deadline for this is set for May of 2020 for H&F to have it done. We will be having a follow up in January. This is a resolution that HD and student congress as a whole see as a necessity.

Garg: This will also increase the inclusivity on campus and with these stickers it will be coinvent for me and other students to know what kind of options are suitable.

Miller: These are good steps for all diets. These would make these more accessible.

Mohamoud: Are Halal foods available in separate places, or available on other places on campus?

Miller: There is a whereas clause that states they are looking for another distributor for Halal foods. The only place that serves Halal food is in Athens. But the idea is that you should be able to go several places on campus.

Garg: The signage would help you know that those options are available to you.

Miller: We don't want the burden to be on students.

Alpert: Is there a reason that this resolution does not include kosher food?

Miller: The University is a business. I had no idea how much went into making food kosher, no food that is not kosher can touch that plate. Food has to be cooked in an oven that no non-kosher food can be cooked in and it is not fusible.

Broadbent: Is there a bibliography?

Miller: Yes.

Broadbent: Would you accept a friendly amendment adding a bibliography?

Miller: Yes.

Lissau: How many students have you reached out to?

Garg: There are 1,700 international students that want this. There are also other OU groups that expressed their wanting this. Vegan options even though not kosher.

Lissau: How is congress going to hold H&F accountable?

Miller: That is the purpose of the follow up meeting in January. He offered the May 2020 deadline.

Alpert: How you can make the food available at congress or during congress events more suitable for dietary restrictions if it's Passover?

Miller: One thing that will be happening at the international Friendsgiving is that we will have offerings for different people with different restrictions, I'm hoping to get a vegan turkey.

Emini: There are some menus above the restaurants in the dining hall in couch restaurants. But sometimes there is either no menu, or the incomplete menus, how would the signage be applied to these?

Miller: We thought about providing pamphlets, which I know is not ideal to have to carry them around, but are broken down by restaurant.

Motion to extend time for questioning by the end of the list Representative Hillis seconded by Representative Carmona

Stormer: Would you accept a Friendly Amendment changing the title from resolution to "increasing inclusivity of Halal, Vegan, and gluten free food in all dining areas"?

Miller: Yes.

Hillis: Are these dietary options only available in certain restaurants?

Miller: The menus are not up to date, but laughing tomato was one, Baja has a few gluten free options,

Quiznos as well, yes. Halal is only available in Athens. These options are listed online.

Tucker: Is there a resource guide that is digitized?

Miller: The online one breaks it down already.

Spangler-Day: Would you accept a Friendly Amendment moving Lauren Miller to author from co-author?

Miller: Yes.

Patterson: Would you accept a friendly amendment adding me as a co-sponsor?

Miller: Yes.

Kordic: What cooperation with H&F have you had to discuss the feasibility to achieve this by the deadlines? Miller: There is already a graphic for halal, gluten free and vegan foods. We are just needing a quote for stickers.

Garg: This is something that housing, and food was already working on and we are holding them accountable.

CB-103-02 An Act Reauthorizing the Congressional Administration Chair for Session 103 (DeAngeli) (Executive Committee> Rec of Do Pass)

DeAngeli: This is the piece of legislation reauthorizing Malachi in his position as ConAd chair. Malachi has done a great job. I will be directing the rest to him.

Bouch: The ConAd chair is in charge of the appointment process; some of you are the product of of this process. Outside of that ConAd will have a few new projects. More recently, an election reform process that will run smoother next year. We are taking input from the committee and even outside of that. I am also planning a Parliamentary Procedure event next semester because the one congress meeting ran late last time. If you are going to vote to abstain, please have an ethical dilemma otherwise vote your goat...wait gut.... This is supposed to have an ethical dilemma. You should have a reasoning to vote already. You guys should be on top of things.

Lissau: Could you elaborate on the changes you would make to the election process?

Bouch: They will mostly be baby steps. Some of them include tying the election position to a more permanent position in SGA or making an ex-officio position on the election board. There will also be some specific changes within the election procedures themselves, such as making them more assessable and clearer. There is some confusion in certain phrases that were and were not acceptable.

Marvin: Could you explain what an ex officio officer?

Bouch: Basically, it means that you hold that position because you hold the other one. Secretary Patterson is the ex officio secretary of the Congressional Administration committee due to the bylaws.

Schneider: What have you done better than the previous ConAd chair?

Bouch: I would use the word better; I would simply use the word differently. There was different project that the previous chair focused on. Which was a cheat sheet for the Code annotated but we have pursued other things. I focus more on being the parliamentarian in the body.

Lissau: Will the election changes you are pursuing affect the programing branch?

Bouch: I have no ideas regarding that as of yet. Doesn't mean we are not open to them.

DeAngeli: I've met with all the committee chairs for at least 30 mins a week every week, they're all doing an awesome job. I will turn it over to them to talk about what they have done this semester.

Miller: We had implicit bias tabling, a poetry and prose night, an international Friendsgiving, an immigration forum, working on affordable housing with OU Democrats, and we had legislation tonight.

Werdel: We updated the code annotated regarding the Student Environmental Coalition. We had an awesome food justice panel. We are now in the process of creating a survey for reusable container program and sending those out. We are also organizing an event for plastic bag use.

Gau: We hosted voter registration drives, planning higher-Ed day and looking into a small business drone delivery service.

Patton: Every week I present you with auxiliary bills. My goal for next semester is hosting a town hall or education of some sort for primary to learn about the physical application. This will be making it easier for them to get through primary alive.

Motion to extend time for authors explanation for 5 minutes Representative Marvin seconded by Representative Lange

Mayes: I am the chair of Campus Outreach Safety and Concerns committee. Last semester served as our planning phase. This past session we focused on solving smaller issues from the suggestion box, such as

making sure that after the games that when they put the concrete barriers up, they do not leave them, so Gina doesn't get hurt. We are also working on getting free child care for students with children and we worked on taking care of the smell. Lastly, we are doing research on the ADA accessibility of building on this campus. DeAngeli: I can vouch for all of them.

Patterson: What will you guys do differently this semester to make sure that all the agendas look uniform? Miller: You sent out that template that was very easy. All I have to do is change the name.

Patton: I have been following the template all year.

Gau: That's actually why I'm quitting.

Lissau: To the outgoing chair of External Affairs, what type of characteristics are you looking for for new person?

Gau: If they are as excited and obsessed about the voter registration drives and higher-Ed day in a weird way like I do you'll be great.

CB-103-08 An Act Establishing Committee Membership for Session 103(DeAngeli) (Executive Committee> Rec of Do Pass)

DeAngeli: This is the bill that established the committees again. I need one friendly amendment to move Zack Lissau from WAM to EA. Everyone got what they wanted unless they didn't get back to me.

Broadbent: Would friendly amendment moving Lissau to EA?

DeAngeli: Yes

CB-103-09 Inclusivity Consistency Act (Gibbs/DeAngeli) (Executive Committee> Rec of Do Pass). Gibbs: Thank you all for seeing me. About a month ago, we presented the Indigenous Land Acknowledgment Act. The purpose of this was to be intentional for the Native students and to be intentional to our University. In order to give us more context of "boomer" and "sooner," Taylor is here to talk about it. Broadbent: basically, sooners were people who illegally came before the land run started and claimed Norman Moore, and Edmond tribal land that the federal government promised the Native population and then took away from them. In 1889, 50,000 people participated a claimed 160 acres. The Sooners were the early runners and the boomers were led by David Payne. The federal government repeatedly removed David and settlers from this land. The Native American population held 100 million acres of land but that decreased to 48 million.

Gibbs: We understand that the boomer and sooner are our mascots for OU and it is a part of our traditions in the university not only in our community but the nation. We wanted to put a lot of thought and consideration into this and we wanted to be more consistent within the SGA. This is why we are mandating a change in the name the Sooner freshman council.

Motion to extend time for questioning by 5 minutes Representative Mohamoud seconded by Representative Spangler-Day

Gibbs: We wanted to ask, what other measures could we take to be more consistent, under the preview of the executive branch. We are proposing this name to be changed because its located in the Code, and for the rebrand to be start, there needed to be a timeline. I wanted to say that this resolution is coming from me, my idea, and I will take full responsibility and reservations for bill. This is not being presented on behalf of an organization. This is coming straight from me. This is not a mandate for the university or other organizations. This is just another way that we can start a conversation. It is the aim of the university to support students.

This is just one more way we can be more inclusive to the university. SFC@ou.edu is the student financial center. There have been mistake emails to them with questions about the sooner freshman council. So this is a timly name change for them as well. Students who are interested don't need to be directed in the wrong place.

Marvin: Would you accept a friendly amendment that addresses section 2 part A striking "all relevant" to remove "all official social media"?

Gibbs: Yes.

Lissau: have you consulted past, former, and future SFC chairs?

Gibbs: I deemed it not necessary for past chairs, but I did discuss this with current chairs. There were reservations, but after a conversation with Logan and Bianca, we decided that it would be beneficial for the organization as a sub branch of executive. So, this would be a seamless transition with new co-chairs. Mohamoud: Would you think it would be a good idea to ask Native students to replace the name? Gibbs: Perhaps that might fall out of the scope of this bill but I think it is a conversation that needs to be

had. I would love to chat with you further or at least get you in the room.

Grebe: Could you expand on the reservations the chairs had?

Gibbs: I do not want to put words in mouths, but there were reservations because these were words that they grew up with. And I think the way I came about it now as not a university mandate and yes I want it to set an example.

Sertovic: How can congress have input in the name?

Gibbs: The way I wondered it, it was only fair to give this back to SFC to come up with their own name change. Congress will have a say in part. They will Collab with exec and then take it to congress. If you didn't approve the name you could fail it and send it back.

Hillis: It is my understanding that SFC falls under the Vice President, is Prince on board?

Gibbs: Prince and I are on the the same page and this is on his radar. Sine anyone can offer a bill, I decided it was better if the head of the branch headed this.

Lange: You stated that you would accept full responsibly, but do you expect much backlash?

Gibbs: I hope not but at the end of the day we need to be respecting our pears. This allows us to recognize the things as an org that we can do better.

Broadbent: Did this idea come from native town halls?

Gibbs: The inspiration, yes. I can't take responsibility for the conversation. But the inititive, yes. No one told me I had to do it and it was my own accord for me to take this up.

Broadbent: But you did talk to native students?

Gibbs: I would not have had this idea without the town hall. They spoke about it at the institutional level but this was something as an organization that we could do. This had become before I had signed the bill. I found it fitting that we could be more consistent.

Marvin: Would you accept a friendly amendment in section 3 replacing "represented"?

Lissau: Is the phrase sooner freshman council used with a negative connotation?

Gibbs: I would refer back to Taylor's context of boomer and sooner.

Motion to extend time to the end of the list

Representative Buxton seconded by Representative Stormer

Broadbent: no one was like "yes let's exclude the native students" but yes boomer and sooner are inherently offensive. Not only did they steal the land, but they were breaking the law. So yes.

Carmona: How effectively do you think this can change at the University level?

Gibbs: I can't tell the university to change anything, but the conversation was already discussed for the university level. This is for our code so I don't know how the next level will take it. There would have to be an elevated discussion outside of SGA all across the state. Greater conversation mascot at the institutional level. Our level does not bring change but impower us to be more forthcoming in the conversation. Not much else I can say or do at the institutional level at least with this bill.

Spangler-Day: Would you say that this is a great first step for lasting change to make Native students more comfortable?

Gibbs: That is my intention.

Lissau: For students in SFC, with new merch that came out, would this alienate the students wearing them? Gibbs: No, I can't tell you what to do with your own clothes, that's a first amendment issue. If you feel that way please come talk to me.

Hillis: Would you accept a friendly amendment adding section 2 A b adding "The name may stay on the webpages only to reference the previous council's name."

Lissau: Have you surveyed the native students about this change?

Gibbs: No, I didn't feel as though it was an appreciate measure. The consensus is clear that it is offensive term. Just like everyone know that blackface is overwhelming offensive. Yes.

Marvin: Will the community be pro to change the mascot?

Gibbs: In Copeland hall at 8pm, there was a Native student town hall hosted by the tribal liaison. This was an open forum to discuss concerns. There was talks about having an Indigenous Land Acknowledgement at the institutional level. I will not name them by name. But there were issues with the Indigenous Land Acknowledgement coexisting with the term's boomer and sooner.

Lissau: Do you have a plan of action if this bill passed to educate the negative connotation boomer and sooner brings?

Gibbs: Personally, no I don't have a plan. My plan is just to make this consistent within the organization. After my term, I would hope that continues. There is only so much I can do until the next administration continues, but yes.

Miller: People are just so protective of it cause it's the mascot but there are real implications.

Broadbent: Would you accept a friendly amendment in section 2 A adding c to put and explanation about why the name way changed.

Gibbs: Yes, I think that would be a good idea.

With this you'll have a 1/1000 chance to be called. You can remove yourself from the registry. You have the opportunity to match with anything. 1/200 people will need a transplant.

CONGRESSIONAL BILL AB-103-01 SENATE BILL NO. GF19-XX

AS INTRODUCED

An act relating to appropriations; providing for short title; stating purpose; appropriating Auxiliary Funding for the 2019-2020 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: This act shall be known and may be cited as the "Auxiliary Allocation 11 Act of 2019-2020"

Section 2: PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.

Section 3: APPROPRIATION. The following amounts are hereby allocated to

A Resolution Increasing Halal, Vegan, and Gluten-Free Signage in Campus Dining Areas; providing for a short title; and providing for distribution

Whereas: The University of Oklahoma's mission is to "create an enhanced learning environment

based on diversity and inclusion."

Whereas: There are rarely signs in dining areas around campus indicating what foods are

gluten-free, Halal, or vegan.

Whereas: The Hindu, Muslim, and Jewish populations have dealt with the uncertainty of not knowing

if the food they are eating is in compliance with their religion. Halal and Kosher are religiously ideal foods for Muslims and Jews respectively and some Hindus are strict

vegetarians as well.

Whereas: Many universities have adapted menus for different religions and international students. The

University of Chicago has developed a dedicated Halal counter in their catering services1 and the University of California accommodates Muslim, vegetarian and vegan students.2

Whereas: A brief survey of Muslim students and faculty showed that they would find it

ideal if food were to be labeled Halal and they could have more options. Due to

inaccessibility of Kosher food on campus, the Jewish student population has resorted to

vegan options.

Whereas: Organizations serving food in the Union have to abide by the rule of using Union

catering, which does not offer Halal food as an option to be served.

Whereas: In events like Housing & Food organized Thanksgiving dinner, only traditional American

food is served which is restrictive for many students from different cultures and with

different diets.

Whereas: Housing & Food is currently looking for a larger distributor for Halal meat.

Whereas: The university already has menus indicating what foods across campus are gluten-free,

vegan, and halal, but they are not advertised.

Whereas: There is no system in place to label these kinds of foods in dining spaces across campus.
