**Vice Chair's Report** – Hi everyone! The Gender and Equality Center was generous enough to print us pronoun stickers. They're here in the first row, we have three options. I would really appreciate if you put the pronouns you identify with on the bottom right hand side of your sticker. It's really important we are constantly trying to be inclusive and consistent. Also, with finals coming around just know you are awesome and if you need a place to study or someone to study with please let us know. If you're new to the body, representative or associate, please let me know what group you would like to liaison for. You won't have a liaison requirement until January but it's important to be proactive just in case the group you want takes some time to respond, thank you!

**Secretary's Report** – Hey guys, this break, I will be going over some things in the bylaws that have to do with my job description among other things. I am also going to attempt to streamline the bill submitting process. If you guys have had any frustrations with anything so far this semester, especially in regard to the bill writing/submitting/presenting process please come talk to me so I know to address the issue. As usual, please be on top of your attendance. Next semester, I will be meeting with the secretaries to have a mini minute's workshop, stay tuned for that date.

### **Committee Reports-**

- **Campus Outreach, Safety, and Concerns:** This semester went well. All big projects will pretty much be after this meeting on Tuesday and in December. After we get those done, I can update you all know how we did and what we can improve on.
- **Congressional Administration:** So, we looked at a bunch of different things and identified projects including election reform. We saw CB-103-10 and CB-103-11 and gave both of them a recommendation of do pass.
- **External Affairs:** I am very proud of External Affairs. This is the best one I've seen out of three sessions. We had a great voter registration drive. We did a lot better in city council meetings and being up to date on the city of Norman.

- **Human Diversity:** We were really great this semester and we are really excited next semester. We had a forum for affordable housing and a forum for mass incarceration, as well as hosting the Friendsgiving.
- **Sustainability:** Our committee also did very well this semester. We've had multiple trash walks, we had a food justice summit, and a reusable upcycling event. Finally, we are also laying the ground work for the reusable container program for OU. This is going to be a really positive thing as long as the university can provide funding. We will also be having a healthy eating event, as well as tabling an education opportunity promoting sustainability through the idea of less waste. Also, Sustainability has an upcycling event on Wednesday, 6-8, community room of biz. With free Fuzzy's tacos!
- **University Policy:** This semester went well. We've had quite a few projects that are still in progress, because there is a lot of communication which takes lots of time. Also, with the mental health project, we will be seeing them next semester.
- **Ways and Means:** Hey guys tonight we will be seeing aux 11 and 12 which will be rounding up auxiliary funding. We have just over \$70,000 left right now before we pass the two bills. At the end of the semester, we will have around \$55,000. That is pretty on par with where we usually are at the end of this semester. I feel really good about this. This semester, I worked a lot with my committee on setting precedent in how we choose the numbers that we give out by defining these lines for example with good, medium, and bad fiscal. AB-103-02 Auxiliary Allocation 12 of 2019-2020 (Patton) (Ways and Means > Do Pass)

Patton: We saw 20 organizations. This is the last auxiliary bill of the year. This bill totaled \$11,334.63. If you guys have any questions about organizations specifically let me know.

Marvin: What is Hacklahoma?

Patton: It is a hacker's convention. So, this is to provide food and rental space for the event itself.

CB-103-10 An Act Appointing the University Policy Chair for Session 103 (DeAngeli) (Congressional Administrations > Do Pass)

DeAngeli: This one is the bill appointing Audrey Heuser as University Policy chair. There was only one candidate for each, but we gave them the same process that we would give to everyone to make sure they were great. She is super prepared and was vice chair and she's been in congress since spring.

Heuser: I am really excited!

Tucker: Do you have any major plans for next semester?

Heuser: I would push more projects. There were communication issues this semester and problems with research. I would be giving people projects that they like so we can get legislation passed.

Lange: Do you have a particular flagship project?

Heuser: There are a couple that we're working on currently. Representative South is working on one with title 9, and I have a few regarding football game safety and menstrual products.

Garg: Considering the number of projects, are any of them parking?

Heuser: We actually looked at parking. It turns out that parking is less feasible than any of us anticipated. But we are looking into more options but at this time we are stuck.

CB-103-11 An Act Appointing the External Affairs Chair for Session 103 (DeAngeli) (Congressional Administration > Do Pass)

DeAngeli: This is the same thing but with Taylor. She is ultra qualified. She's also very involved in politics outside OU which helps with the external part of the committee. She will be working on getting people to go to city council which is really cool.

Hardt: What would you do differently than the last external affairs chair?

Broadbent: I will give specific projects out for specific people instead of just working on one project at a time.

Tucker: Are there any particular projects that you are interested in working on?

Broadbent: Well, higher-Ed day mostly but I also want to assign different liaisons to different parts of government. I will be working with George on a census. There are some other things that might come up that will require my committee to write more legislation.

Bouch: Will you accept a resolution condemning Baylor for showing the collapse of the schooner 4 times at the game?

Broadbent: I'm not sure if I'm qualified. I guess it's EA's purview. I guess I'm open to it but no promises it will pass.

CR-103-01 A Resolution Increasing the inclusivity of Halal, Vegan, and Gluten-Free foods in Campus Dining Areas (Garg/Miller) (Human Diversity Committee > Do Pass)

This is saying that there must be a sign that states the staff are not cooking gluten free food in a separate area and note that the cooks are simply just changing the gloves.

AS INTRODUCED

An act relating to appropriations; providing for short title; stating purpose; appropriating Auxiliary Funding for the 2019-2020 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

- Section 1:** This act shall be known and may be cited as the “Auxiliary Allocation 12 Act of 2019-2020”
- Section 2:** PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.
- Section 3:** APPROPRIATION. The following amounts are hereby allocated to

A Concurrent Resolution to promote diversity, equity,

- Whereas: Those who comprise the university of Oklahoma's student body come from a variety of backgrounds and experiences.
- Whereas: The University of Oklahoma is considered above average in ethnic, gender, geographic, and overall diversity.<sup>1</sup>
- Whereas: Unfortunately, the University of Oklahoma also has a history of insensitivity and bigotry, from the racist "Little Red" mascot in the 1950s to the incidents of Blackface in 2019.
- Whereas: Several initiatives have already been created to combat racist forces on our campus- like the multicultural advancement committee- but we as the Student Government Association legislative branch should also define and solidify our continued efforts.

BE IT RESOLVED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

**Section 1:** Title: This resolution shall be known and may be cited as the "Resolution for Diversity, Equity, and Inclusion within the Student Government Association."

  - Conduct a review of the SGA Code Annotated and respective Bylaws to identify and remove exclusionary practices.
- External Affairs of GSS and Campus Outreach, Safety, and Concerns of USC:
  - Gather opinions from the student body regarding room for improvement in diversity and inclusion at the university.
- External Affairs of USC
  - Continue advocating for inclusive related issues when conducting business internally and externally at the University.
- Human Diversity of GSS and USC:
  - Continue activities.
- Sustainability of GSS and USC:
  - Continue to review inclusive and accessible practices within the realm of sustainable initiatives.
- University Policy of USC:
  - Review other schools' diversity, equity, and inclusion practices and initiatives.
- Academic Affairs of GSS:
  - Review the University of Oklahoma's diversity, equity, and inclusion practices and initiatives.
- Ways and Means of GSS and USC:
  - Consider implementing diversity-specific practices in their processes.
- Public Relations of GSS:
  - Focus on outreach to multicultural groups and offering them services from Student Government Association.
- Philanthropy of GSS:
  - Conduct a review of groups for which they are providing resources and include any underrepresented parties.

AS INTRODUCED

A Resolution Increasing Halal, Vegan,  
and Gluten-Free Signage in Campus Dining Areas;  
providing for a short title; and providing for distribution

Whereas: The University of Oklahoma’s mission is to “create an enhanced learning environment based on diversity and inclusion.”

Whereas: There are rarely signs in dining areas around campus indicating what foods are gluten-free, Halal, or vegan.

Whereas: The Hindu, Muslim, and Jewish populations have dealt with the uncertainty of not knowing if the food they are eating is in compliance with their religion. Halal and Kosher are religiously ideal foods for Muslims and Jews respectively and some Hindus are strict vegetarians as well.

Whereas: Many universities have adapted menus for different religions and international students. The University of Chicago has developed a dedicated Halal counter in their catering services<sup>2</sup> and the University of California accommodates Muslim, vegetarian and vegan students.<sup>3</sup>

Whereas: A brief survey of Muslim students and faculty showed that they would find it ideal if food were to be labeled Halal and they could have more options. Due to inaccessibility of Kosher food on campus, the Jewish student population has resorted to vegan options.

Whereas: Organizations serving food in the Union have to abide by the rule of using Union catering, which does not offer Halal food as an option to be served.

Whereas: In events like Housing & Food organized Thanksgiving dinner, only traditional American food is served which is restrictive for many students from different cultures and with different diets.

Whereas: Housing & Food is currently looking for a larger distributor for Halal meat.

Whereas: The university already has menus indicating what foods across campus are gluten-free, vegan, and halal, but they are not advertised.

Whereas: There is no system in place to label these kinds of foods in dining spaces across campus.

THEREFORE, BE IT RESOLVED BY THE STUDENT GOVERNMENT ASSOCIATION:

Section 1: Title: This resolution shall be known and may be cited as “A Resolution Increasing the inclusivity of Halal, Vegan, and Gluten-Free foods in Campus Dining Areas.”

Section 2: Housing & Food should develop signage on menus across campus clearly showing what foods are gluten free, vegan, and halal.

Section 3: Housing & Food has said halal, gluten-free and vegan foods will be labeled by May 2020.

Section 4: ~~Housing & Food should place signage that indicates that preparation of gluten free food is not done in a separate area.~~

Section 5: Housing and Food should provide more vegan, Gluten-free and Halal options at various areas on campus.

Section 6: Congress should hold Housing & Food accountable to their promise of increasing signage for Halal meat, gluten-free, and vegan foods by May 2020.

CONGRESSIONAL BILL CB-103-09  
SENATE BILL NO. GF19-28

AS INTRODUCED

An Act of Legislation mandating  
a name change for the “Sooner Freshman Council”;  
providing for short title,  
providing for codification, and  
providing for an effective date.

**Section 1:** This Act shall be known as the “Inclusivity Consistency Act”

- A. Student Government Association strives to be an inclusive organization.
- B. The word “Sooner” might be harmful in nature to those who identify American Indian or of Native/Indigenous descent.
- C. The Student Government Association wants to be consistent in its application of an Indigenous Land Acknowledgment at its events and ceremonies.
- D. The Student Government Association just passed, signed, and subsequently codified an Indigenous Land Acknowledgement in the Code Annotated creating Title XII.
- E. The Student Government Association must strive to include all, thereby mandating a more sensitive name must be selected and instituted within the first two weeks of the Fall semester in year 2020.

**Section 2:** This Act shall give the Executive Branch in collaboration with the Co-Chairs of Sooner Freshman Council a deadline of September 1st, 2020.

- A. The name that replaces “Sooner Freshman Council” must have the following stipulations:
  - a. The name “Sooner Freshman Council” or “SFC” must be taken off all official social media including handles.
  - b. The use of the word “Freshman” must be changed to “First Year Undergraduate Student”

- c. The name must be changed on all websites including registered student organization portals including but not limited to, the SGA Website and OrgSync. The name may stay on the webpages only to reference the previous council's name
- d. An explanation of the reasoning behind the name change shall be added to the SGA Website and OrgSync.

**Section 3:** Once the new name is proposed, it must be submitted to the Executive Branch including but not limited to the President and/or Vice-President within the time specified in Section 2.

- A. Once the Executive Branch approves the name, it must be presented to the Legislative through the appropriate committees and will thereby be subject to review by the Undergraduate Student Congress and Graduate Student Senate.

**Section 4:** This act shall become effective when passed in accordance with the SGA Constitution.
