CB-102-14 SGA Superior Court Appointment Act of 2019 (Ridenour/Merchant)

Ridenour: Hi, my name Emma Ridenour, I am currently the Chief of Staff in the executive branch. This past week or so we conducted interviews for the Superior Court. We came up with three really amazing people, first, Cameron Burleson, a 2nd year OU law student, second, Hunter McCans, a previous congress representative and, third, Riddhi Yadav, also a previous congress representative. The interview board was comprised of the former Chief Justice, GC, a Congress representative, and me. These were the three who had the best interviews best answers in regard to their possible bias and in regard to the Code Annotated. They also had the best interpretations and rulings when asked about that.

Bouch: Could you tell us about some of the questions that were asked?

Ridenour: Sure, mostly there were questions about the knowledge of the Code Annotated. There were scenarios for possible election issues. There were questions about bias because all three of them had had prior Student Government Association experience. But we never saw these biases as a problem because we found them to be upstanding members of the organization. Lastly, we gave them a piece written by GC and they had to interpret it.

Thompson: Directing my question to the appointees, could you give the body brief blurb about why you wanted to join the Superior Court.

Burleson: Well, back when I was going through the process in 2016, JD baker and I ran for SGA President and Vice President. Through that process we heard about Superior Court and the election board and we hear about their job to make things fair. The court is not just a body that makes decisions but a body that upholds the integrity of the Student Government Association. I don't know if you guys remember, but in 2016, there was a very contested presidential election and the Superior Court allowed that vetting and integral process of holding the candidates accountable, to occur and they upheld the rules and I want to be that for someone else.

McCans: I've been here, in Congress, for several years now. I am always looking for ways to serve the student body and this seemed like a good next step for me.

Yadav: I am actually fairly new here to the body, but I am so passionate about the court because there are little things that has to go through congress. I am very involved in learning new things. I have had past experiences and have been involved in politics and campaigns. This, in the Superior Court is where I would love to be and I would love to have more responsibilities.

CB-102-11 Indigenous Land Acknowledgment (Chiariello/Patterson)

Chiariello: Hello, my name is Taylor Chiariello and I am the Co-inclusivity chair in the executive branch. This is the Indigenous Land Acknowledgment Act for SGA events. I am not sure if you are aware, there has been both opposition and support with this. Adran and I are aware of this. I was president of the American Indian Student Association in the past, so I am very familiar with the community. We want to set a standard for honor and history of the Native American community especially with the current native students and staff. I am open to questions because I am sure there has been discussion.

Gibbs: This bill was a concern when talking to the students. But we want to emphasize the importance of recognizing the land that we are on. We want to be intentional, if we set example we can continue to be engaged with the community. This is a model that we hope can be expanded beyond SGA events to events such as graduations, inaugurations, etc.

Chiariello: Basically, we just want to start a movement and we would like your support with this. Bouch: Has the American Indian Student Association's new executive team seen this bill?

Gibbs: They specifically have not, but we have maintained active conversation with the indigenous community. Actually, the template was approved and written by Bri Farris, who was the American Indian Programs and Services Advisor.

Chiariello: The majority of the community really did support this and the intent behind the acknowledgment is really the purpose of passing this, we don't want to just be checking off diversity boxes.

Chism: Would you accept a friendly amendment creating section 2Biv stating "appropriate settings at the discretion of the directing organization of the event,"?

Gibbs: Yes.

Chism: Would you accept a friendly amendment changing section 2Biiib to state "Rah Rally" and move all other events down one to reach to point f?

Gibbs: Yes.

Chism: Lastly, would you accept a friendly amendment adding Jema Esparza as a co-Author Author?

Gibbs: Yes.

Marvin: Who wrote the statement?

Gibbs: Bri Farris wrote the actual statement.

Marvin: Do you all have any idea why the Cato and Wichita tribes were the only two mentioned? Chiariello: These were the ones who are native to this land specifically. They needed the most

recognition.

Bouch: Is the the exact speech that needs to be read every time or can it be tailored to a specific event?

Gibbs: There is language in the bill that says it can be tailored to a specific event.

Broadbent: Can this be sent to the President of the American Indian Student Association? As well as other communities pertinent to this bill?

Chiariello: So, I don't know if the current American Indian Student Association President specifically is aware of the legislation. We have had discussion meetings with multiple parts of community, we invited the American Indian Association and other members of faculty and staff and hosted involved meetings. The community not only understands but is Aware.

Broadbent: Would you accept a friendly amendment sending this to the OU daily?

Gibbs: Absolutely.

Chiariello: We do want the American Indian Student Association to be involved with this movement as it grows.

Harman: When looking at events, could we add a friendly amendment adding camp crimson. This way we can introduce this tradition to freshman coming in.

Gibbs: The problem with that is that there is no way to enforce this. We would need to talk to the director of Camp Crimson. I would love that, if it were in the form of a Resolution but, in bill form, we cannot impose this on them. They should be doing it but we cannot tell them they have to.

Hillis: In your opening, you discussed some opposition, can you elaborate on this push back?

Chiariello: Yeah, they want to understand that it's not just a check off a diversity box. We as a collective as executive of the SGA that we want to recognize and honor the Native American community on whose land we reside and learn on and we would one day want other organizations to follow in the footsteps SGA once they see why it is important.

CB-102-18 Problems and Projects Committee Reform Act (Mayes/DeAngeli) (Problems and Projects > Do Pass) (Congressional Administration > Do Pass)

Mayes: Problems and Projects as it stands is the oldest committee in history of the body. George, a previous chair of Problems and Projects, a million years ago. He was also a member a million years ago. This is a bill to change the name and purpose. Problems and Projects is juvenile. Ways and Means and University Policy and Sustainability are much more mature than Problems and Projects. That committee sounds like it belongs in high school. Campus Safety and Concerns incapsulates the committee's purpose. If we left it as Problems and Projects, I would want to get rid of the committee. But I am the chair, so I don't want to do that. Changing the purpose allows the chairs to address what they would like to address.

Thompson: Don't you think Campus Safety and Concerns is incapsulated is Problems and Projects? Mayes: Yes, but so are Human Diversity and University Policy because it is a broad name.

Thompson: Can you just change the purpose?

Mayes: When I first gave this speech in March to Emma, Mahak, and Savanah, there was a good speech about how words matter. Words matter. A name like Problems and Projects was not taken seriously as much as the others.

Spangler-Day: Everything underlined is new? Mayes: Yes. Spangler-Day: Does the committee mandate itself?

Mayes: The last sentence allows members and chair to write out issues excluding infrastructure. Just so they do not infringe on other committees.

Thompson: Do you think that the way that the committee is taken seriously is more related to the impact on campus than the name?

Mayes: Problems and Projects has had a big impact. Not to throw the previous chairs under the bus. I do not think the committee was living up to the potential. I liked Tim, he was a brave soul, a fighting man, a Massachusetts man. It is not the way Problems and Projects conducts itself on campus. This is not the way it should show its worth.

Miller: When you discuss changing issues on campus, what have you done in the past that you will not do now?

Mayes: Problems and Projects was a catch all committee. Problems and Projects should not be the only one conducting the suggestion box. The posters with the outdated LGBTQ terminology I would have had to send to Human Diversity anyway.

Thompson: Do you think adding 12 syllables could more change the effect than changing the purpose? Mayes: I don't think it matters?

Chism: Do you think that this would allow students to more likely reach out to this committee? Mayes: If they know...

Mayes: Problems and Projects stands for all problems and all projects. If they see a committee called Campus Safety and Concerns, they are more likely to want to talk to them. So yes, it does help. Sure, it's a little wordy but I don't think anyone really cares. If certain students have certain problems, they'll know where to go. They can look at my info and know where to go.

Chism: Is changing name and purpose allowing you to do more things related to your committee? Mayes: Yes, when I was vice chair, every problem came to us. Everything came to us from Tom, if we have a narrower focus, we now have a larger amount of time regarding those issues. Instead of spending a lot of times on things that do not belong to this committee.

Bouch: Is the Campus Safety and Concerns abbreviation "COSCO" juvenile as well? Mayes: I will take suggestions.

Wegrzynski: You mentioned redundancy, do you think that outreach and concerns is redundant. Can you not name it just Campus Safety?

Mayes: We address more than just safety. We will handle more concerns than most committees. Thompson: As former chair of the Problems and Projects committee, my experience is that the committee was easily accessible, and students thought we could take care of everything. I found that we could fix everything. Do you think this restricts students' access?

Mayes: I think it will do the opposite. Your experience has not been my experience.

#### CONGRESSIONAL BILL CB-102-11 SENATE BILL GSXX-XX/GFXX-XX

#### AS INTRODUCED

## An Act of Legislation implementing the Indigenous Land Acknowledgement Statement in SGA events; establishing Title XII of the Code Annotated; providing for short title, providing for codification, and providing for an effective date.

## BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

**Section 1**: Title: This act shall be known and may be cited as the "Indigenous Land Acknowledgement Act."

**Section 2**: Purpose: The purpose of this act shall be to implement an Indigenous Land Acknowledgement (ILA) statement as campus-wide introduction that shall be recited before designated events in order to honor the Indigenous community on campus as well as the rich American Indian heritage and history of our University and state.

Section 3: NEW LAW: A new chapter and Title is hereby established in Title XII of the Code Annotated to read as follows:

Title XII: Tribal Recognition Chapter 1: Indigenous Land Acknowledgement

1. ILA Template

"Before we begin today, The Student Government Association would like to take a moment to honor and recognize the rich heritage and traditions of the land and its peoples on which we are gathered today.

Long before David Ross Boyd envisioned the University of Oklahoma, the land on which we gather today served as a site of meeting and exchange amongst many Indigenous peoples. Tribes such as the Caddo and Wichita and Affiliated tribes called this land home long before the University of Oklahoma was envisioned or established. Today, 39 tribal nations dwell within the state of Oklahoma as a result of policies that were designed to assimilate Native people and strip them of their diverse and sacred cultures and traditions.

This land acknowledgment statement is a public expression of gratitude and honor for the people who have been living on and cultivating this land from time immemorial. Today, many Native people represent their families and tribes from across the land as Indigenous students, faculty and staff here at the University of Oklahoma.

- 2. Requirements
- A. The Indigenous Land Acknowledgment shall be stated before the start of SGA events. SGA For the purpose of this Act, tabling on the South Oval should not be considered an event. Further exclusions shall be recurring meetings such as Undergraduate Student Congress Meetings, Graduate Student Senate Meetings, Executive Cabinet meetings, and any informal or formal committee or department that occur on a recurring basis.

- C. Appropriate statement formats
  - i. The ILA shall be stated orally, recorded and made into a video, or recorded audio. Wording should mimic this document, or be approved by the Office of Student Life for guidance on appropriate wording.
- **Section 4:** This act shall become effective when passed in accordance with the SGA Constitution.

#### CONGRESSIONAL BILL CB-102-18

#### AS INTRODUCED

A Congressional Act of Procedure amending the Undergraduate Student Congress Bylaws; providing short title; providing for codification; and providing an effective date.

## BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION UNDERGRADUATE STUDENT CONGRESS:

- Section 1: Title: This act shall be known and may be cited as the "Problems and Projects Committee Reform Act of 2019".
- **Section 2:** Purpose: The purpose of this act shall be to amend the name, committee purpose, and committee chair role of the Problems and Projects Committee in order to ensure a more comprehensive committee that can adequately address student concerns.
- Section 3: AMENDATORY: Section 7.1.4 of the Undergraduate Student Congress Bylaws is amended as follows:

4. PROBLEMS AND PROJECTS CAMPUS OUTREACH, SAFETY, AND CONCERNS

**Section 4:** AMENDATORY: Section 7.1.4a of the Undergraduate Student Congress Bylaws is amended as follows:

a. COMMITTEE PURPOSE The Problems and Projects <u>Campus Outreach</u>, <u>Safety</u>, and <u>Concerns Committee</u> shall use the Student Congress' resources to manage outreach projects for the Student Congress, resolve all problems <u>concerns</u> regarding university infrastructure, student experience, and all other student problems <u>concerns</u> that the Student Congress <u>the committee</u> mandates itself can reasonably respond to address.

**Section 5:** AMENDATORY: Section 7.1.4b of the Undergraduate Student Congress Bylaws is amended as follows:

b. COMMITTEE CHAIR The Committee Chair shall be charged with maintaining and following up with the Undergraduate Student Congress electronic suggestion box.

The Committee Chair shall coordinate with the Congress Chair to refer suggestion box submissions to other committees, should they appropriately fall under another committee's responsibilities. The Committee Chair shall work with the Directors of the Department of Inclusivity and Interior in the executive branch to address campus safety and all other student concerns that fall within the committee's purview and mandate.

**Section 6:** AMENDATORY: Section 7.6.4ci of the Undergraduate Student Congress Bylaws is amended as follows:

	i. Congress Chair, Congress Vice-Chair, Congress Secretary, Congressional Administration Committee Chair, External Affairs Committee Chair, Human Diversity Committee Chair, Problems and Projects <u>Campus Outreach</u> , <u>Safety</u> , and <u>Concerns Committee</u> Chair, University Policy Committee Chair, and Ways and Means Committee Chair.
