We are tabling CB-102-20 because the candidate cannot make it because he has class.

**Vice Chair's Report** – I have been working on the liaison program this past week. There will be some training to make sure there is no miscommunication. I am still working on some logistics. Good job in the committee meetings this week. There might be a parli pro workshop for those who are confused or struggling. I love seeing all the new faces in the Conoco. Afterwards the meeting, come to the Conoco so we can play a game.

**Secretary's Report** – Hey guys! Thank you all for coming today. Somethings that I wanted to touch on for a bit was a tiny run down on absences that are excused versus not excused. Some excused absences are obviously if you have an exam during this time as well as if you have a class. This is mainly for associates, if you are a representative with a class during this time please come talk to me. Lastly if you are sick you are excused. Please don't come and get everyone else sick. Some unexcused absences will be "I don't feel like coming" thankfully I have not heard that one so yay. But a main unexcused absence that I will not be taking is a busy schedule. That is something that everyone in this body struggles with and sympathizes with, and as a representative it is important that you make every meeting possible to ensure that you are representing your constituents. This is a time commitment. If you are struggling with unexcused absences, come talk to me during my office hours, I'm not an unreasonable person. We can work something out.

**Committee Reports-**

**Campus Outreach Safety and Concerns:** The Registered Student Organization swap takes place Thursday Oct 3<sup>rd</sup>. RSOs have offices filled with junk. Basically, we are putting all junk outside the offices and the different organizations can come swap different things that they

need. Lastly, the first light walk of session 102 is Wednesday, September 18<sup>th</sup> (tomorrow). I have a meeting with Kris Glen from parking services later.

**Congressional Administration:** We saw CB-102-20 and we gave it a recommendation of do pass. Sam would be a good election board chair. We also discussed the Student Legal Services Bill that we saw in Executive committee.

- **External Affairs:** We are currently working on Voter Registration day that will take place September 24<sup>th</sup>. We will be partnering with Carl Alberts Fellows and OU Votes. We will be in charge of setting up booths, but External Affairs is mainly in charge of class speeches. We are looking into passing legislation on SGA supporting voting. Finally, we discussed the transportation on busses. OU operates the cart services but now its transitioning to the Norman services. Students are worried that they might now be charged for certain destinations and we are looking into it.

**Human Diversity:** We have an official date for Implicit Bias tabling which will be October 7<sup>th</sup> 9am-3pm. We need people to sign up for a time. Finally, we are working on the rest of our projects.

- **Sustainability:** Sustainability committee had a great week! Lots of people joined us for our trash walk on Sunday- hope to see you all at the next one! This week we worked with housing and food to promote their reusable cup policy and continued with the rest of our projects.
- **University Policy:** Hi, everyone! UPOL met and projects were assigned to each member. The first project is training professors to accommodate students with mental health problems or disabilities through a new faculty orientation reform in partnership with the DRC. The second project is reviewing repercussions for professors who have harassed students through some type of policy revision. The third project is increasing menstrual products accessibility and affordability. We're looking into what progress the Department of Interior and Goddard's Project PERIOD have made on this front. Lastly, we're partnering with Housing & Food, OU Food Pantry, and Food Recovery Network to create a system of donated meal swipes and points to be available as meal vouchers. Let me know if you'd like to learn more about any of these projects, and I can get you connected with the right member! Thanks!

**Ways and Means:** We saw Auxiliary Funding 3 in committee Sunday. Then we talked about how to discuss Auxiliary stuff then we saw Auxiliary 4. We are going to work next week on them talking more.

## **Liaison Reports**

### **Special Orders**

Adran Gibbs, SGA President

Adran: Thank you for having me. Quick updates on executive branch. First, an overview of cabinet, the first set of Progress Reports are next Monday. They were supposed to be this Monday, but someone had a concussion. Last spring, we got funds from the student activity fee reserve board to renovate the Sarkey's fitness center which is going to be about a 600k renovation. There will be new equipment, artwork. Basically, we are making sure that the fitness center is up to standards. Recently we all went to Stillwater and we toured their fitness center and we are very much behind all the big 12. We are a flagship institution and we need to have the facilities that we deserve. That construction will start December at the earliest. If we can get the resources in time. At latest it will be completed at the end of this coming summer. The Department of Interior is working on the artwork. There will be a class competition at OU. Whoever submits the best design will be approved to decorate the gym to add a personal touch and to get art students involved. OU loves Norman will be in late October maybe the 22<sup>nd</sup> or the 25<sup>th</sup>, sometime that week. For some of the new members, we put on OU loves Norman to bridge the relationship with the city and the university. This is an effort to ease tensions and work with the city as much as possible. Our cabinet is also expanding the menstrual product drive, in which students donated these products for free. We started with the PanHellenic council. We got two trucks full of them for the food pantry that is a badly needed product. Moving into the high-level things that Prince, Emma, and I are working on, we are trying to boot up Rent College Pads. This

program is like a Zillow for college students. Platforms like Zillow are not optimized for college students. We are talking about bringing this platform to OU so we can create an off campus living platform. Not everyone lives in the dorm after their freshman year. We want to create a way for students to be informed about the places they lived so they don't get ripped off. We are having those conversations through the end of the month and hopefully they will be solidified by end of November. Dr. Smith oversees all academic advising, we had a meeting with her to really understand the root of unsatisfactory advising. We all have had a less than optimal advising experience; we need to figure out how to have that productive conversation. They will be coming to have a discussion with SGA members. We went to big 12 and one of our core objectives is strengthen the branding of SGA. This is so the students will know exactly what we do. They look at us as elite and that causes the disconnect. To fix this, we are working on a couple different measures. That is why we need to know the mission statement. For OU loves Norman, we are looking for ways to partner with city. Mayor's first round table will streamline concerns at the OU level and then be represented at the city level.

Hardt: With the gym under construction, will students be allowed to go?

Gibbs: We are trying to be very strategic by splitting the gym construction into two blocks so that one block will be completed over Christmas break and the other over the summer when people are less likely to be there. But some parts of the gym will remain accessible.

CB-102-13 Student Legal Services Establishment Act (Gibbs/DeAngeli) (Executive Committee > Do Pass)  
Gibbs: Now we are looking at the Student Legal Services program. Last spring, we needed some additional time to look into the program to make sure we are properly advising, considering we have a financial stake in the program. Over the summer we brought a consultant who is the the program director for SLS at UC Berkley who did a full assessment to tell us if we are on the right track with this program. He consulted with Tracy Lankford, our attorney, George, me, and Student Affairs. We all discussed how we should move forward. Student Legal Services provides students with legal advice. Compared nationally Student Legal Services is not found in the Student Government Association and are usually found in Student Affairs or at the University level, I was supposed to be chairing the committee overseeing this board but I do not have a law degree and we cannot advise the professional. We also run into Attorney client privilege issues as well as the issue of always needing to be in executive committee which inhibits the amount of updating I can give to congress. The Gender and Equality Center used to be an SGA initiative. But now they are a separate entity.

**Motion to extend time for questioning by 5 minutes**  
**Representative Alpert seconded by Representative Gau**

Gibbs: We still have a stake in the program. If there were an issue about the direction of the program or with the attorney, we could still fix things. We want to move this attorney from part to full time, proving that Student Legal Services is a stable success. As SGA it is on us to start programs. SGA has led the fight with this and we need to prove to the University that this is a stable program that needs to grow in the right position and I think in Student Affairs, it would work best there.

Spangler-Day: Under section 3, 2<sup>nd</sup> clause, what does that wording mean? I do not understand exactly what its saying?

Gibbs: We wanted to leave flexibly for the program to grow. The director of Student Legal Services has a gateway class to teach legal things that students might not know. We want to introduce an advocacy position.

Hardt: In section 4, it states their salary is \$41,200. How does this compare nationally?

Gibbs: Keep in mind that this is a part time job for her, coming in at about 20 hours a week. Doubling that it would be about 80,000 per year. This is a piolet program so pay is relatively competitive give her credentials.

This also is not taking into consideration fringe benefits which does add to the amount of money.

Spangler-Day: For now, this is funding by SGA, but in the future the university will fund it?

Gibbs: Well, either way this money is going to come out of the student activity fee. Hopefully this transition will move quickly. I hope when it does pass, we can get a quick fund transfer to Student Affairs. After talking to George this is something that we can do pretty quickly. We are thinking about middle of next semester.

Merchant: Is it possible to get this done before new administration?

Gibbs: Yes and no, barring shifting funds complication, we are hoping that it can be finished relatively quickly by end of semester.

Garg: Could you elaborate on section 3 when it says the attorney would have a limited scope?

Gibbs: Yes, there is a statute found in the Oklahoma Constitution that defines what limited scope means, but from my understanding, she cannot represent you in court. She can, however, provide consultation for free.

This is big because 3 hours with an outside attorney is expensive.

Garg: Can they write court notices? If someone has to file a petition, can they file it?

Gibbs: I'm not an attorney, so I don't know, I can write it down and ask later because I do not want to give false information.

Bouch: To clarify, the advisory board has been disbanded?

Gibbs: Yes.

Tucker: Why can the attorney not provide legal advice against OU student and faculty?

Gibbs: There is a complicated conflict of interest because OU cannot sue OU.

**Section 3:** Appointment: In accordance with Title IV, Chapter 6, Section 25, Subsection A of the SGACA “*The Election Chair shall be appointed by the SGA President with the advice and consent of the Legislative Branch,*” the following student shall be appointed as the SGA Election Board Chair:

SENATE BILL

AS INTRODUCED

An Act of Legislation creating the University of Oklahoma Student Legal Services Program as a program of the Student Government Association; creating the paid position of OU SLS Staff Attorney within SGA; Establishing Title XI, Chapter 3 of the Code Annotated; Amending Title X, Chapter 5 of the Code Annotated; providing short title; providing for codification; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

**Section 1:** Title: This act shall be known and may be cited as the “Student Legal Services Establishment Act”

**Section 2:** Purpose: The purpose of this act shall be to outline the mission of the OU Student Legal Services program, establish the rights of students using the program, set guidelines for the SLS staff attorney, establish the role of the OU SLS Advisory Committee, define the financial rules for SLS, and establish the salary for the OU SLS Staff Attorney.

**Section 3:** NEW LAW: A new chapter is hereby established in Title XI of the Code Annotated to read as follows:

Title XI: SGA Non-Financial Resources  
Chapter 3: Student Legal Services

1. Student Legal Services Purpose

The purpose of Student Legal Services (SLS) is to provide students at the University of Oklahoma with legal services and legal educational opportunities necessary to maximize the benefits derived from their rights and responsibilities as a citizen or resident of the United States of America and the State of Oklahoma.

2. Eligibility for Services

#### A. Eligibility

Any currently enrolled student at the University of Oklahoma shall be entitled to receive services from OU SLS. Any student who was enrolled at the University of Oklahoma shall be permitted to seek the services of OU SLS regarding events which occurred during, or stemmed from, their last semester of coursework at OU for sixty (60) days immediately following their graduation.

#### B. Nondiscrimination Policy

Access to OU SLS shall be open to all students without regard to race, color, creed, religion, national origin, disability, public assistance status, veteran status, sexual orientation, gender identity or expression, citizenship status, or immigration status.

### 3. Services Offered

A. OU SLS offers “Limited Scope” legal representation to students free of charge. Limited Scope legal representation includes

i. Legal advice, education and guidance, consultations, Notary Services OU SLS may not offer services to students if:

i. The student’s legal issue is against another OU student, an OU faculty or staff member, or the University itself.

### 4. Rights of OU SLS Clients

#### A. Attorney-Client Privilege

i. Clients of OU’s Student Legal Services Program are entitled to the benefits of the attorney-client privilege, and

ii. The OU SLS staff attorney shall not be considered a mandatory reporter as this would be a violation of clients’ attorney-client privilege.

#### B. Confidentiality

All clients of OU SLS shall be entitled to confidentiality. The SLS staff attorney shall have no duty to reveal the identities of students that have utilized the program. The SLS staff attorney shall have the authority to collect, keep, maintain, and protect client files and client data consistently with the position and the laws of the State of Oklahoma. However, nothing in this clause shall limit the staff attorney’s ability to release non-identifying client information for program assessment, evaluation, marketing, or other reasonable and legitimate purpose.

### 5. SLS Attorney

OU Student Legal Services shall employ at least one (1) staff attorney for a minimum of twenty (20) hours per week, and shall hold the title of “Director of OU Student Legal Services”

#### A. Qualifications

The staff attorney shall be licensed by the Oklahoma Bar Association. The staff attorney shall remain in good standing with the Oklahoma Bar Association for the duration of their employment with OU SLS, including completing annual continuing legal education (CLE) requirements. The staff attorney shall fulfill all other requirements for employment at the University of Oklahoma.

#### B. Professional Responsibility

The staff attorney shall follow all norms of professional responsibility of the legal profession including, but not limited to, the Rules of Professional Conduct promulgated by the Oklahoma Supreme Court.

#### C. Employment Decisions

The OU Vice President for Student Affairs shall ultimately be responsible for making any decisions regarding the employment of the OU SLS staff attorney, in accordance with all appropriate university policies.

6. Staff Attorney Independence

No person, group, organization, or entity shall interfere with the independent professional judgment of the staff attorney as mandated by the Rules of Professional Conduct promulgated by the Oklahoma Supreme Court.

7. Finances

- A. The OU SLS staff attorney shall be paid a salary with benefits, as defined by Title X.
- B. The OU SLS staff attorney shall be entitled to be reimbursed for costs associated with annual CLE requirements. This cost shall be borne by the SGA Executive Branch.
- C. All costs associated with the office expenses of the OU SLS program shall be covered by the SGA Operations Account
- D. All costs associated with marketing shall be borne by the SGA Executive Branch.
- E. Any outside funding dedicated to the program shall be maintained in a separate account by the SGA Budget and Account Representative and may be used by the SGA Executive Branch to cover the expenses of the program.

**Section 4:** AMENDATORY: Title X, Chapter 5, Section 30 is amended as follows. All additions are underlined and all deletions are marked with a strikethrough:

Section 2: The following positions shall receive a salary:

- Associates of General Counsel: \$11.00 x 25 hours/week x 34 weeks
- General Counsel: \$12.00 x 25 hours/ week x 48 weeks
- Chief of Staff: \$10.00 x 10 hours/week

The Chief of Staff shall be appointed by the SGA President following an open application process.

- Election Board Members: 5 per election, \$40x5 persons x 2 general elections
- Election Chair: \$350/Spring General Election, \$350/Fall General Election
- Election Poll Operators: 20 Individuals per election, \$20x20x 2 elections

Election Board Members, Chair, and Poll Operators are appointed according to the Elections Procedures Act.

- SGA Staff Assistant II: \$16.40/hour x 2080 Hours
- SGA Budget and Account Representative II: \$17.66/hour x 2080 Hours

The above positions are selected based upon applications received through the HR website, jobs.ou.edu. Selections are made by the SGA President, SGA Vice President, Congress Chair, Senate Chair, and CAC Chair, as well as their staff supervisor in Student Affairs. Increases in pay are given at the discretion of the aforementioned officials. Additionally, if university wide raises are mandated, the above positions shall receive those increases.

- Student Organization Resource Officers: \$10.00 x 10 hours/week per officers
- SGA Graphic Designer/Webmaster: \$10 x 10hours/ week x 34 weeks

The above positions are selected based upon applications received through the HR website, jobs.ou.edu. Selections are made by the SGA President, SGA Vice President, Congress Chair, Senate Chair, and CAC Chair.

- OU Student Legal Services Staff Attorney: \$41,200 per year.

The OU SLS Staff Attorney shall be hired according to the policies outlined in Title XI. The staff attorney shall be eligible for benefits at a value of the current fringe benefits rate per OU HR policy.

Any position not enumerated above shall not receive a salary/stipend.

**Section 5:** The SGA General Counsel is empowered to correct any clerical issues found within this bill or which arise as a result of passage of this bill.

**Section 6:** This act shall become effective when passed in accordance with the SGA Constitution.
