CONGRESSIONAL ACT NO. 920312

AS INTRODUCED

A congressional act authorizing a survey of the student body on behalf of the Undergraduate Student Congress; providing for specific questions; and providing for distribution.

NOW, THEREFORE, BE IT ENACTED BY THE UNDERGRADUATE STUDENT CONGRESS THAT:

Section 1: TITLE: This act may be known and shall be cited as the “24/7 Bizzell Survey Act of 2014.”

Section 2: PURPOSE: To establish a poll to determine if there is a high student demand for a 24/7 section of the Bizzell Library that would justify the costs of creating this section.

Section 3: The Election Board shall survey undergraduate students to determine if there is a need to section off an area in the Bizzell Library that would be open 24/7. This survey shall assist Dean Richard Luce, dean of University Libraries, in his decision to choose whether or not to establish such an area.

Section 4: The questions in this survey are as follows unless the Problems and Projects chair or the general assembly at large determines they need to be amended to accurately determine its goal:

CONGRESSIONAL ACT NO. 920313

AS INTRODUCED

A congressional act authorizing a survey of the student body on behalf of the Undergraduate Student Congress; providing for specific questions; and providing for distribution.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

- Section 1:** Title: This act shall be known and may be cited as the “Bike Lane Survey of 2014.”
- Section 2:** Purpose: The purpose of this act shall be to establish a survey to find out the necessity of bike lanes from students’ perspective.
- Section 3:** With the conversion of the south oval, students are able to bicycle from the west side of campus to the east side without having to worry about buses. However they are still required to weave between pedestrians and pedestrians must worry about staying out of the way of bicyclists.
- Section 4:** The election board shall survey students to discover the need of a bike lane running from Elm Street to Jenkins Avenue. As students are the eyes and ears of campus, the survey will also ask students for other areas on campus that are in need of bike lanes.
- Section 5:** The questions in this survey are as follows unless the Problems and Projects chair or the general assembly at large determines they need to be amended to accurately determine its goal:
Bike Lane Survey:
After arriving on campus, do you generally walk or bike to different areas of campus?

B) Bike/Skateboard/etc.
C) About 50/50

Would you be in support of a dedicated bike lane, similar to the one running north-south on the South Oval, running east-west from Jenkins Avenue (north of the football stadium) to Elm Avenue/Brooks Street (Goddard Health Center)?
